3 FOR the purpose of requiring, on or before a certain date each year, an electric company to submit a certain electrical service restoration plan to the Public 4 $\mathbf{5}$ Service Commission for a certain purpose; requiring the plan to address certain 6 matters; requiring the Commission to review the plan and take certain actions; 7 requiring, on or before a certain date each year, the Commission to issue final 8 approval of the plan; requiring the Commission to use all powers and authority 9 to enforce this Act; and generally relating to the creation of an electrical service 10 restoration plan.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That the Laws of Maryland read as follows:

ON OR BEFORE JULY 1 OF EACH YEAR, AN ELECTRIC COMPANY 20(A) 21SHALL SUBMIT AN ELECTRICAL SERVICE RESTORATION PLAN TO THE 22COMMISSION TO ESTABLISH PRIORITIES FOR THE RESTORATION OF 23ELECTRICAL SERVICE IN THE EVENT OF AN EXTENDED DISRUPTION TO 24**ELECTRICAL SERVICE.**
