The holder of the license may keep for sale and 30 sell beer and light wines at retail to bona fide members and their guests, at any club, 31 at the place described in the license, for consumption on the premises only.

- 12 (a) (1) A Class A beer, wine and liquor license shall be issued by the license issuing authority of the county in which the place of business is located. The license authorizes the holder to keep for sale and to sell all alcoholic beverages at retail, in any quantity, at the place described in the license. The licensee shall deliver the alcoholic beverages in a sealed package or container and the package or container may not be opened nor its contents consumed on the premises where sold.
- 18 (e) In Baltimore County the annual license fee [is \$600] SHALL BE 19 ESTABLISHED AS PROVIDED IN § 18–105 OF THIS ARTICLE.

- (a) (1) A Class B beer, wine and liquor license shall be issued by the license issuing authority of the county in which the place of business is located, and the license authorizes its holder to keep for sale and sell all alcoholic beverages at retail at any hotel or restaurant at the place described, for consumption on the premises or elsewhere, or as provided in this section.
- 26 (e) (2) The annual fee for a license [is \$1,000] SHALL BE ESTABLISHED 27 AS PROVIDED IN § 18–105 OF THIS ARTICLE.

- (a) (1) Except as provided in subsection (n) of this section, a Class C beer, wine and liquor license shall be issued by the license issuing authority of the county in which the place of business is located. It authorizes the holder to keep for sale and sell all alcoholic beverages at retail at any club, at the place described in the license, for consumption on the premises only.
- 34 (e) In Baltimore County the annual license fee [is \$500] SHALL BE 35 ESTABLISHED AS PROVIDED IN § 18–105 OF THIS ARTICLE.

- 2 (a) (1) A Class D beer, wine and liquor license shall be issued by the license issuing authority of the county in which the place of business is located. It authorizes the holder to keep for sale and sell all alcoholic beverages at retail at the place described in it, for consumption on the premises or elsewhere. A license may not be issued for any drugstore.
- 7 (e) (2) The annual license fee [is \$1,000] SHALL BE ESTABLISHED AS 8 PROVIDED IN § 18–105 OF THIS ARTICLE.

- 10 (b) In this section "caterer" means a Class B or Class D on—sale beer, wine 11 and liquor licensee who contracts to provide food and sell alcoholic beverages to 12 sponsors of public or private events held off the premises.

- 9 (a) This section applies in Baltimore County.
- 10 (b) The Board of License Commissioners may issue a Class BWT beer and light wine (on–premises) tasting license to the holder of a Class A beer and light wine license.

- 3 \$25.00 per day]; and shall be entitled to procure a license for the sale of beer, wine and
