A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loans of 2002 and 2009 – Montgomery**
3 **County – MacDonald Knolls Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loans of 2002
5 and 2009 to extend the deadline for the Board of Directors of CHI Centers, Inc.
6 to present evidence that a matching fund will be provided for a certain grant;
7 requiring that the Board of Public Works expend or encumber the proceeds of
8 the loans by June 1, 2013; and generally relating to amending the Maryland
9 Consolidated Capital Bond Loans of 2002 and 2009.

Chapter 485 of the Acts of 2009

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
10 MARYLAND, That:

11 (3) ZA02 HOUSE OF DELEGATES LEGISLATIVE INITIATIVES

12 (AI) MacDonald Knolls Center. Provide a grant equal to the lesser
 13 of (i) \$100,000 or (ii) the amount of the matching fund
 14 provided, to the Board of Directors of CHI Centers, Inc. for the
 15 repair, renovation, reconstruction, and capital equipping of
 16 the MacDonald Knolls Center, located in Silver Spring.
 17 **NOTWITHSTANDING SECTION 1(5) OF THIS ACT, THE**
 18 **GRANTEE HAS UNTIL JUNE 1, 2013, TO PRESENT**
 19 **EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED.**
 20 **NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THE**
 21 **PROCEEDS OF THE LOAN MUST BE EXPENDED OR**
 22 **ENCUMBERED BY THE BOARD OF PUBLIC WORKS FOR**
 23 **THE PURPOSES PROVIDED IN THIS ACT NO LATER THAN**
 24 **JUNE 1, 2013** (Montgomery County) **100,000**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 June 1, 2011.
