Maryland–National Capital Park and Planning Commission – Prince George's County – Site Plan Approval Authority

4 FOR the purpose of prehibiting authorizing the County Council for Prince George's 5 County, sitting as the district council, from reviewing to review decisions by the 6 Prince George's County Planning Board to approve or disapprove certain site 7 plans except under certain circumstances; authorizing a party of record to 8 appeal certain decisions by the Planning Board to the district council; requiring 9 the district council to decide whether to conduct a certain review within a 10 certain number of days; requiring the district council to conduct a certain review hearing within a certain number of days unless that period of time is 11 extended in certain circumstances; requiring the district council to issue a 12certain decision within a certain number of days; prohibiting the district council 13 from revoking certain delegations of approval authority made to the Planning 14 Board by a certain date; authorizing the district council to revoke certain 15 16 delegations of approval authority for the purpose of delegating that authority to 17 the governing bodies of certain municipal corporations; and generally relating to 18 site plan approval in Prince George's County.
