A BILL ENTITLED

1 AN ACT concerning

Creation of a State Debt – Charles County – Bel Alton High School Community Development Center

4 FOR the purpose of authorizing the creation of a State Debt not to exceed \$100,000, the proceeds to be used as a grant to the Board of Directors of the Bel Alton $\mathbf{5}$ 6 High School Alumni Association Community Development Corporation for $\mathbf{7}$ certain development or improvement purposes; providing for disbursement of 8 the loan proceeds, subject to a requirement that the grantee provide and expend 9 a matching fund; establishing a deadline for the encumbrance or expenditure of 10 the loan proceeds; and providing generally for the issuance and sale of bonds 11 evidencing the loan.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That:

14The Board of Public Works may borrow money and incur indebtedness on (1)15behalf of the State of Maryland through a State loan to be known as the Charles 16 County – Bel Alton High School Community Development Center Loan of 2011 in a 17total principal amount equal to the lesser of (i) \$100,000 or (ii) the amount of the 18 matching fund provided in accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale, and delivery of State general obligation bonds 19 20authorized by a resolution of the Board of Public Works and issued, sold, and delivered in accordance with §§ 8-117 through 8-124 of the State Finance and Procurement 2122Article and Article 31, § 22 of the Code.

(2) The bonds to evidence this loan or installments of this loan may be sold
as a single issue or may be consolidated and sold as part of a single issue of bonds
under § 8–122 of the State Finance and Procurement Article.

26 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer 27 and first shall be applied to the payment of the expenses of issuing, selling, and

1 delivering the bonds, unless funds for this purpose are otherwise provided, and then $\mathbf{2}$ shall be credited on the books of the Comptroller and expended, on approval by the 3 Board of Public Works, for the following public purposes, including any applicable 4 architects' and engineers' fees: as a grant to the Board of Directors of the Bel Alton $\mathbf{5}$ High School Alumni Association Community Development Corporation (referred to 6 hereafter in this Act as "the grantee") for the construction, repair, renovation, 7reconstruction, and capital equipping of a community development center, including 8 window repair, located in La Plata.

9 (4) An annual State tax is imposed on all assessable property in the State in 10 rate and amount sufficient to pay the principal of and interest on the bonds, as and 11 when due and until paid in full. The principal shall be discharged within 15 years 12 after the date of issuance of the bonds.

13 Prior to the payment of any funds under the provisions of this Act for the (5)14purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching fund. No part of the grantee's matching fund may be provided, either 1516 directly or indirectly, from funds of the State, whether appropriated or 17unappropriated. No part of the fund may consist of funds expended prior to the 18effective date of this Act. The fund may consist of real property or in kind 19contributions. In case of any dispute as to the amount of the matching fund or what 20money or assets may qualify as matching funds, the Board of Public Works shall 21determine the matter and the Board's decision is final. The grantee has until June 1, 222013, to present evidence satisfactory to the Board of Public Works that a matching 23fund will be provided. If satisfactory evidence is presented, the Board shall certify this 24fact and the amount of the matching fund to the State Treasurer, and the proceeds of 25the loan equal to the amount of the matching fund shall be expended for the purposes 26provided in this Act. Any amount of the loan in excess of the amount of the matching 27fund certified by the Board of Public Works shall be canceled and be of no further 28effect.

(6) The proceeds of the loan must be expended or encumbered by the Board of Public Works for the purposes provided in this Act no later than June 1, 2018. If any funds authorized by this Act remain unexpended or unencumbered after June 1, 2018, the amount of the unencumbered or unexpended authorization shall be canceled and be of no further effect. If bonds have been issued for the loan, the amount of unexpended or unencumbered bond proceeds shall be disposed of as provided in § 8–129 of the State Finance and Procurement Article.
