14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15	MARYLAND, That the Laws of Maryland read as follows:

18	(a) The Commission consists of 9 members, appointed by the Governor, AS
19	PROVIDED IN SUBSECTION (C) OF THIS SECTION, with the advice and consent of
20	the Senate.
21	(b) At the time of appointment and qualification:

23	(i) at least 25 years old;

[(c)] **(D)** 4 A member of the Commission may not hold an official (1) $\mathbf{5}$ relation to a licensee or hold any stocks, bonds, or other financial interest in a licensee. 6 (2)Not more than 4 members who are appointed after July 1, 1989, 7 may have a financial interest in racing in the State. 8 Not more than 6 members may be of the same political party. (ii) the findings of the Governor; and

(iii) a record of the proceedings.

3 [(g)] (H) The Governor shall appoint one member of the Commission to 4 serve as a liaison to the State Lottery Commission established under Title 9 of the 5 State Government Article.

6 SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the 7 General Assembly that the terms of the members of the State Racing Commission 8 serving on October 1, 2011, expire on that date and that the Governor reconstitute the 9 Commission using the procedure described in this Act.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 October 1, 2011.
