# 2 Credit Unions – Boards of Directors – Electronically Conducted Elections

- 3 FOR the purpose of authorizing the election of the board of directors of a credit union 4 to be conducted electronically under certain circumstances; requiring the  $\mathbf{5}$ secretary of a credit union, for an election of directors conducted electronically, 6 to provide certain information and a certain identification form to certain 7 members of the credit union as provided in regulations adopted by the 8 Commissioner of Financial Regulation; requiring the Commissioner to establish 9 by regulation procedures for conducting an election of directors electronically; 10 making certain conforming and stylistic changes; and generally relating to elections of the board of directors of a credit union. 11

6 7 8	(a) Subject to the provisions of this section, the directors may be elected exclusively by mail ballot OR ELECTRONICALLY IN ACCORDANCE WITH REGULATIONS ADOPTED BY THE COMMISSIONER, if:
9 10 11 12	(1) The board of the credit union, by resolution posted conspicuously at the principal office of the credit union at least 90 days before the annual meeting of the members of the credit union, [authorize] AUTHORIZES the election of directors exclusively by mail ballot OR ELECTRONICALLY; or

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 1  $\mathbf{2}$ October 1, 2011.
