Frederick Alliance for Youth has provided after school programs, summer camps, and family coaching since May of 2008. The Alliance increased the number of people served from 64 to 284 (a 344% increase) from 2009 to 2010. Not only are increasing numbers being served, but they are being served effectively as proven by program outcomes (An outcomes chart, which illustrates program effectiveness, is available upon request). Program goals are to: maximize academic achievement, reduce juvenile crime, empower families to support themselves, and promote community integration.

With State of Maryland funding, Frederick Alliance for Youth proposes to build a youth and community center, located in the struggling Hillcrest community. This Center will provide the opportunity to expand existing youth and family programs and catalyze change for the Hillcrest community.

11. Description and Purpose of Project (Limit Length to Visible area)

The Hillcrest and Waverley neighborhoods on the west end of the City of Frederick are in need of support. Students from these communities are less likely to receive an advanced score on math and reading standardized tests:

- -17% of Hillcrest Elementary School students earned an advanced score on math standardized tests compared to 31% of Frederick County's students earning the same score.
- -17% of Hillcrest Elementary School students earned an advanced score on reading standardized tests compared to 36% of Frederick County's overall elementary student body.

Poverty and crime are also issues to be addressed. Over 70% of Hillcrest students qualify for Free and Reduced Price Meals and in 2009 56% of the city's robberies involving firearms occurred within these communities.

A youth and community center will expand the availability of effective youth and family programs. When managed effectively, this building will provide an energizing and transformational community hub.

Appraised property value is \$700,000, but seller has agreed to the \$680,000 price in a letter of intent to purchase providing a "soft match" of \$20,000. The broker is donating services for both property acquisition and lessee acquisition. The total value of this service equals \$100,000.

The Ausherman Family Foundation has committed \$2,350,000 to Frederick Alliance for Youth's capital campaign, providing a substantial portion of total funding required. All other funds listed in question number 13 are prospective major gifts. A gift range table has been developed which outlines a fundraising strategy for the capital campaign and these prospective funders are included in this strategy.

The lessee is a charter school which is mission driven to provide educational opportunities to underserved families and children. This is a strong complement to Frederick Alliance for Youth's mission and the lessee will therefore be a program partner and not simply a financial partner. While children will be chosen to attend the school based on the charter school lottery system, Frederick Alliance for Youth staff will ensure that the neediest children of the target community will be entered in the lottery.
