Alcoholic Beverages - Baltimore County - License Fees

This bill increases various license fees for the sale of alcoholic beverages in Baltimore County.

Fiscal Summary

State Effect: None.

Local Effect: Baltimore County revenues increase by approximately \$350,600 annually beginning in FY 2012. County expenditures are not affected.

Small Business Effect: Meaningful impact on small businesses that are alcoholic beverage licensees, as most alcoholic beverages license fees are increased by at least 100%.

Analysis

Bill Summary/Current Law: The bill increases licensing fees in Baltimore County for the sale of alcoholic beverages as shown in **Exhibit 1**.

Local Fiscal Effect: Baltimore County received \$704,000 in revenues from alcoholic beverages licenses, permits, and charges for related services in fiscal 2010. The county had 748 active retail licensees in fiscal 2010. The increase in alcoholic beverages licensing fees, as shown in Exhibit 1, will generate an additional \$350,600 in revenues annually beginning in fiscal 2012.
