10. Description and Purpose of Grantee Organization (Limit Length to Visible area)

The City of Mount Rainier is a local government in Prince George's County incorporated in 1910 having just celebrated it's 100th anniversary. The city is a full-service municipality providing all major services including public safety, and public works (trash, recycling and snow removal). The goal of the city is to provide quality service to its citizenry that promotes the safety, health, and well-being of the community. The city is an older community inside the beltway that is the true gateway to Prince George's County bordering the District of Columbia. The city's main business district is situated in the Arts and Entertainment District along the Route1 corridor and has been subject to abandoned and vacant property as well as businesses that are now defunct. The civic center project is designed to create a center for government services convenient to pedestrians, drivers, and users of public transportation as the civic center is adjacent to a WMATA bus terminal, and one that because of the design and location will spur investment opportunities along the Route 1 corridor and thus revitalize the downtown through its main street development.

11. Description and Purpose of Project (Limit Length to Visible area)

This project involves the completion of design drawings for a new state of the art library facility and connecting this library to two existing structures, the former Star Potts Hall and the City of Mount Rainier Municipal Building to create a government civic center complex. The city has been awarded a Senate Bond Bill towards the razing and construction of a new library/civic center as the current conditions of the library include a building that too small to accommodate persons who are unemployed, underemployed and/or of low-to-moderate income levels, who readily seek the use of computers in the library for employment opportunities. The city has also outgrown the space at city hall which has no kitchen facilities or meeting space to accommodate over 50 persons, and no storage capability for files, office supplies, etc. With the recent purchase of the Star Potts Hall, the city has the capability of hosting community meetings and council meetings in a larger space on two levels, as well as create administrative offices for code enforcement personnel, a private conference room, and enlarge the studio control room for cable television. Once the design is complete, the project will also involve the rehabilitation of the Star building including the kitchen facilities on the first floor, the opening of all boarded windows, and refurbishing of the ground floor

28. Comments: (Limit Length to Visible area)

The proposed project will undoubtedly revitalize the city's downtown in conjunction with providing opportunities for larger meeting spaces for the local government and citizenry. The city government has outgrown its current municipal building and has a current need to relocate some of its administrative staff. The division of code enforcement which includes three full-time code enforcement officers, currently operates in a trailer in the garage of the city's public works department. This work environment is not suitable as the trailers' total work space is approximately 8ft x 32ft and results in an overcrowded work space. The civic center project is designed to create a more suitable work space for these three employees.

Additionally, the city's elected officials will have a space conducive to hosting a larger capacity for public hearings and public council meetings.

The space allocated in the basement of the current municipal building that serves as the control room for the Mount Rainier Television Department is also too small. This cable department consists of a director, and two camera operator/technicians, with numerous pieces of equipment including monitors, cameras, mixers, computers, video and audio equipment, CD's and DVD's. The control room is approximately 2 feet x 6 feet. The entire area has no storage closets. This project also addresses the need for expanding the city's ability for live broadcasts of council meetings and taping of various television shows which are used to expound upon items brought up at council meetings enabling the staff to better educate the citizenry about civic events, on-going problems and accomplishments.

This project is also designed to enhance the city's ability to revitalize an area in the community within the gateway arts district. It will bring into one facility consisting of three buildings a host of community services to include but not be limited to payments for fees and services, city elections, payments for parking tickets, various applications for business occupancy and rental licenses, library services, reading/community room for local residents and visitors.

The goal to build a new state-of-the art library to house additional computers for on-line employment opportunities and resume writing and research is another component of the project.

The funds for this bond bill will be utilized to complete the design phase of the project to enable the city to proceed with permits and construction.
