5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
6 MARYLAND, That Section(s) 8–702 through 8–709 of Article – Election Law of the
7 Annotated Code of Maryland be repealed.

8 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
9 read as follows:

10 **Article – Election Law**

11 8–701.

12 (a) The population count used after each decennial census for the purpose of
13 creating the congressional districting plan used to elect the State’s Representatives in
14 Congress:

15 (1) may not include individuals who:

16 (i) were incarcerated in State or federal correctional facilities,
17 as determined by the decennial census; and

18 (ii) were not residents of the State before their incarceration;
19 and

20 (2) shall count individuals incarcerated in the State or federal
21 correctional facilities, as determined by the decennial census, at their last known
22 residence before incarceration if the individuals were residents of the State.

23 (b) The State is divided into eight districts for the election of the State’s
24 Representatives in Congress.

25 (c) (1) The descriptions of congressional districts in this subtitle include
26 the references indicated.

27 (2) **(I)** The references to:

28 **[(i)] 1.** election districts and wards are to the geographical
29 boundaries of the election districts and wards as they existed on April 1, **[2000] 2010**;
30 and

31 **[(ii)] 2.** precincts are to the geographical boundaries of the
32 precincts as reviewed and certified by the local boards or their designees, before they
33 were reported to the U.S. Bureau of the Census as part of the **[2000] 2010** census

1 redistricting data program and as those precinct lines are specifically indicated in the
2 P.L. 94-171 data or shown on the P.L. 94-171 census block maps provided by the U.S.
3 Bureau of the Census and as reviewed and corrected by the Maryland Department of
4 Planning.
