AMENDMENT NO. 1

On page 1, in line 4, strike "or" and substitute a comma; in the same line, after "managers" insert "<u>and councils</u>"; in line 5, after "plan;" insert "<u>requiring a county to address</u>, in a certain recycling plan, a method for implementing a reporting requirement for certain recyclable materials under certain circumstances;"; in the same line, after "requiring" insert "<u>certain</u>"; in the same line, strike the first "or" and substitute a comma; in the same line, after "managers" insert "<u>, and councils</u>"; strike beginning with "requiring" in line 11 down through "date;" in line 13 and substitute "<u>authorizing a county to require certain property owners</u>, managers, and councils to report to the county on recycling activities;"; and in line 19, strike "by owners or managers of" and substitute "<u>in</u>".

AMENDMENT NO. 2

On page 3, strike beginning with "THE" in line 3 down through "AND" in line 6 and substitute "THE COLLECTION AND RECYCLING OF RECYCLABLE MATERIALS FROM RESIDENTS OF APARTMENT BUILDINGS AND CONDOMINIUMS THAT CONTAIN 10 OR MORE DWELLING UNITS BY PROPERTY OWNERS OR MANAGERS OF APARTMENT BUILDINGS AND COUNCILS OF UNIT OWNERS OF CONDOMINIUMS;
