AMENDMENT NO. 1

On page 1, in line 13, strike “(AV)” and substitute “(AB), (AV)”; and in the same line, strike “(BH)” and substitute “(I), (BH)”.

On page 2, in line 10, after “2010” insert “and Chapter 396 of the Acts of the General Assembly of 2011”; in line 18, after “(AA)” insert “and (BG)”; in the same line, after “(X),” insert “(AQ)”; after line 22, insert:

“BY repealing and reenacting, with amendments,

Chapter 485 of the Acts of the General Assembly of 2009

Section 1(3) Item ZA00(S)

BY repealing and reenacting, with amendments,

Chapter 485 of the Acts of the General Assembly of 2009, as amended by

in line 25, after “(AH),” insert “(AI)”; in line 26, after “(BB),” insert “(BG)”; in the same line, after “(AM),” insert “(AN)”; and in line 27, after “(AZ),” insert “(BD)”.

On page 3, in line 1, strike “(BF)” and substitute “(U), (BF)”; and in the same line, strike “(BB-1)” and substitute “(X) and (BB-1)”.

On page 3, after line 19, insert:

“(AB) [The Amphitheater at Bainbridge] HISTORIC TOME

(Over)

SCHOOL. Provide a grant equal to the lesser of (i) \$100,000 or (ii) the amount of the matching fund provided, to the Board of Directors of the Bainbridge Development Corporation, Inc. for the planning, design, repair, renovation, reconstruction, and capital equipping of the [amphitheater] **HISTORIC TOME SCHOOL**, located at the former Bainbridge Naval Training Center, in Bainbridge, **SUBJECT TO A REQUIREMENT THAT THE GRANTEE GRANT AND CONVEY A HISTORIC EASEMENT TO THE MARYLAND HISTORICAL TRUST. NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2013** (Cecil County) 100,000".

On page 4, after line 8, insert:

“(I) Robert A. Pascal Youth Counseling Clinic. Provide a grant equal to the lesser of (i) \$100,000 or (ii) the amount of the matching fund provided, to the Board of Directors of the Robert A. Pascal Youth and Family Services, Inc. for the planning, design, construction, renovation, and capital equipping of a clinic to provide comprehensive counseling services to high-risk youth and families, located in Severna Park. Notwithstanding Section 1(5) of this Act, the matching fund may consist of in kind contributions. **NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2013** (Anne Arundel County)..... 100,000".

On page 5, in lines 12 and 26, in each instance, strike “2014” and substitute “2013”.

On page 6, in line 34, after “2010” insert “, as amended by Chapter 396 of the Acts of 2011”.

On page 7, in line 6, strike “St. Mary’s City” and substitute “Leonardtown”.

On page 7, in lines 16 and 30, in each instance, strike “Baseball” and substitute “MULTIPURPOSE”; in lines 21 and 35, in each instance, strike “baseball” and substitute “MULTIPURPOSE”.

On page 8, after line 24, insert:

“(BG) Button Farm Historic Preservation and Rehabilitation. Provide a grant equal to the lesser of (i) \$125,000 or (ii) the amount of the matching fund provided, to the Board of Directors of The Menare Foundation, Inc. for the planning, design, construction, repair, and renovation of the Button Farm, located in Germantown. Notwithstanding Section 1(5) of this Act, the matching fund may consist of in kind contributions or funds expended prior to the effective date of this Act and the grantee must present evidence that a matching fund will be provided by June 1, [2012] 2013. NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2013 (Montgomery County)..... 125,000”.

On page 9, after line 10, insert:

“(AQ) Button Farm Historic Preservation and Rehabilitation.

Provide a grant equal to the lesser of (i) \$175,000 or (ii) the amount of the matching fund provided, to the Board of Directors of The Menare Foundation, Inc. for the planning, design, construction, repair, and renovation of the Button Farm, located in Germantown. Notwithstanding Section 1(5) of this Act, the matching fund may consist of in kind contributions or funds expended prior to the effective date of this Act and the grantee must present evidence that a matching fund will be provided by June 1, [2012] 2013. NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2013 (Montgomery County) 175,000”.

On page 10, after line 12, insert:

“Chapter 485 of the Acts of 2009

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That:

(3) ZA00 MISCELLANEOUS GRANT PROGRAMS

(S) Robert E. Lee Park. Provide a grant to the County Executive and County Council of Baltimore County for the design [and], construction, AND CAPITAL EQUIPPING of improvements to Robert E. Lee Park in Baltimore County, subject to the requirement that the grantee provide an equal and matching fund for this purpose. Notwithstanding the provisions of Section 1(5) of this Act, the matching fund may consist of funds expended prior to the effective date of this Act (Baltimore County)..... 3,000,000

(3) ZA03 LOCAL SENATE INITIATIVES

(AK) Black Rock Center for the Arts. Provide a grant equal to the lesser of (i) \$50,000 or (ii) the amount of the matching fund provided, to the Board of Trustees of the Germantown Cultural Arts Center, Inc. d / b/ a Black Rock Center for the Arts, Inc. for the planning, design, construction, and capital equipping of the Black Rock Center for the Arts, located in Germantown. Notwithstanding Section 1(5) of this Act, the matching fund may consist of in kind contributions and the grantee has until [December 1, 2012] **JUNE 1, 2013**, to present evidence that a matching fund will be provided. Notwithstanding Section 1(7) of this Act, [the proceeds of the loan must be expended or encumbered by the Board of Public Works for the purposes provided in this Act no later than December 1, 2012] **THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2013** (Montgomery County)..... 50,000".

On page 12, after line 23, insert:

“(AI) Troy Regional Park. Provide a grant equal to the lesser of (i) \$225,000 or (ii) the amount of the matching fund provided, to the County Executive and County Council of Howard County for the design, construction, and capital equipping of the Troy Regional Park, located in Elkrige. **NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS GRANT MAY NOT**

TERMINATE BEFORE JUNE 1, 2013 (Howard County) 225,000”.

On page 13, strike in their entirety lines 7 through 18, inclusive.

On page 14, after line 2, insert:

“(BG) La Vida Sana (Healthy Living Farm). Provide a grant equal to the lesser of (i) \$50,000 or (ii) the amount of the matching fund provided, to the Board of Directors of the Engaged Community Offshoots, Inc. for the acquisition, design, and construction of the Healthy Living Farm, located in Edmonston. Notwithstanding Section 1(5) of this Act, the matching fund may consist of real property, in kind contributions, or funds expended prior to the effective date of this Act AND THE GRANTEE HAS UNTIL JUNE 1, 2013, TO PRESENT EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED. NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2013 (Prince George’s County) 50,000”.

On page 16, after line 7, insert:

“(AN) Troy Regional Park. Provide a grant equal to the lesser of (i) \$230,000 or (ii) the amount of the matching fund provided, to the County Executive and County Council of Howard County for the design, construction, and capital equipping of the Troy Regional Park, located in Elkrige. NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2013 (Howard County) 230,000”;

strike beginning with “NOTWITHSTANDING” in line 11 down through “PROVIDED.” in line 14; and after line 27, insert:

“(BD) La Vida Sana (Healthy Living Farm). Provide a grant equal to the lesser of (i) \$25,000 or (ii) the amount of the matching fund provided, to the Board of Directors of the Engaged Community Offshoots, Inc. for the acquisition, design, and construction of the Healthy Living Farm, located in Edmonston. Notwithstanding Section 1(5) of this Act, the matching fund may consist of real property, in kind contributions, or funds expended prior to the effective date of this Act AND THE GRANTEE HAS UNTIL JUNE 1, 2013, TO PRESENT EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED. NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2013 (Prince George’s County)..... 25,000”.

On page 19, before line 1, insert:

“(U) HopeWell Cancer Support Facility. Provide a grant equal to the lesser of (i) \$75,000 or (ii) the amount of the matching fund provided, to the Board of Trustees of HopeWell Cancer Support, Inc. for the planning, design, construction, repair, renovation, reconstruction, and capital equipping of the HopeWell Cancer Support Facility, located in Lutherville. NOTWITHSTANDING SECTION 1(5) OF THIS ACT, THE GRANTEE HAS UNTIL JUNE 1, 2013, TO PRESENT EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED. NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2013 (Baltimore County) 75,000”;

and after line 25, insert:

“(X) HopeWell Cancer Support Facility. Provide a grant equal to the lesser of (i) \$100,000 or (ii) the amount of the matching fund provided, to the Board of Trustees of HopeWell Cancer Support, Inc. for the planning, design, construction, repair, renovation, reconstruction, and capital equipping of the HopeWell Cancer Support Facility, located in Lutherville. NOTWITHSTANDING SECTION 1(5) OF THIS ACT, THE GRANTEE HAS UNTIL JUNE 1, 2013, TO PRESENT EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED. NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2013 (Baltimore County) 100,000”.

On page 20, in line 4, strike “Corridor” and substitute “OWINGS MILLS BOULEVARD SOUTH”; in line 9, strike “the”; strike beginning with “Corridor” in line 9 down through “ROAD” in line 10; in line 11, after “SOUTH” insert “FROM LIBERTY ROAD TO WINANDS ROAD”; and in line 13, after “EXPENDED” insert “FOR OWINGS MILLS BOULEVARD SOUTH AND LIBERTY ROAD”.
