# A BILL ENTITLED

### Cultural Competency and Health Literacy – Education

- 3 FOR the purpose of requiring the Maryland Office of Minority Health and Health 4 Disparities to work collaboratively with certain universities and colleges of  $\mathbf{5}$ social work, public health, and allied health to develop certain courses; changing 6 the name of the Cultural and Linguistic Health Care Provider Competency 7Program to be the Cultural and Linguistic Health Care Professional 8 Competency Program: altering the purpose of the Program; including a certain 9 association and certain entities among the groups that are encouraged to 10 identify, develop, or collaborate in the development of certain training 11 programs; altering the requirements for certain training programs; altering 12certain definitions; requiring a certain report from certain universities, colleges, 13 and higher education programs to certain committees of the General Assembly and the Maryland Office of Minority Health and Health Disparities on or before 14a certain date; and generally relating to cultural and linguistic competency and 1516 health literacy.

4 (b) The purpose of the Program is to provide for a voluntary program in 5 which educational classes are offered to health care [providers] **PROFESSIONALS** to 6 teach health care [providers] **PROFESSIONALS**:

(1) Methods to improve the health care [provider's] **PROFESSIONALS'** cultural and linguistic competency to communicate with non–English speaking patients and patients from other cultures who are English speaking;

10 (2) Cultural beliefs and practices that may impact patient health care 11 practices and allow health care [providers] **PROFESSIONALS** to incorporate the 12 knowledge of the beliefs and practices in the diagnosis and treatment of patients; and

(3) Methods to enable health care [providers] PROFESSIONALS to
increase the health literacy of their patients to improve the patient's ability to obtain,
process, and understand basic health information and services to make appropriate
health care decisions.

18 The Medical and Chirurgical Faculty of Maryland, the State Medical Society, 19 the Maryland Nurses Association, the Maryland State Dental Association, the 20 National Association of Social Workers – Maryland Chapter, the Maryland Society for 21 Clinical Social Work, the Maryland Psychological Association, THE MARYLAND 22 PHARMACISTS ASSOCIATION, or any other health professional association OR 23 PUBLIC HEALTH ENTITY in the State is encouraged to identify training programs, or, 24 if feasible, to develop or collaborate in the development of training programs, that:

(1) Address ethnic language or racial groups of interest to the health
care [provider] PROFESSIONAL members;

#### HOUSE BILL 679

1 The Department of Health and Mental Hygiene shall develop a method through 2 which the appropriate professional licensing board recognizes the training received by 3 health care [providers] **PROFESSIONALS** under this subtitle, either through 4 continuing education credits or otherwise.

 $\mathbf{5}$ SECTION 2. AND BE IT FURTHER ENACTED. That, on or before December 1. 6 2012, universities, colleges, and higher education programs of medicine, nursing, 7pharmacy, dentistry, social work, public health, and allied health in the State shall 8 report to the Senate Education, Health, and Environmental Affairs Committee, the 9 House Health and Government Operations Committee, and the Office of Minority Health and Health Disparities on the courses that have been developed independently 10 11 by the colleges, universities, and higher education programs or through a collaboration 12with the Office of Minority Health and Health Disparities under § 20–1004(15) of the 13 Health – General Article, as enacted by Section 1 of this Act.

# 14 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 15 July 1, 2012.
