BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: 11 12 Article - Education 13 7 - 804. 14 (a) In this section, "school vehicle" has the meaning stated in § 11–154 of the Transportation Article. 15 16 Except as provided in paragraphs (2) and (3) of this subsection, (b) 17 unless it fails to meet the applicable school bus and motor vehicle safety standards, a 18 school vehicle may be operated for 12 years. 19 In CALVERT, Caroline, Dorchester, Somerset, Talbot, (2)20 Wicomico, and Worcester counties, unless it fails to meet the applicable school bus and 21motor vehicle safety standards, a school vehicle may be operated for 15 years.
