- 22 (u) (1) The Office of the Comptroller may issue a winery special event 23 permit to a licensed Class 4 Maryland limited winery, provided that:

3	issued to the Class 4 Maryland limited winery in any given calendar year;		
4	(ii) The permit does not exceed 3 consecutive days; and

6	(11), AND (12) of this subsection, no more than three winery special event permits are		
7	issued in any calendar year to any given limited winery for use in the same political		
8	subdivision.		
9	(12) IN ADDITION TO THE WINERY SPECIAL EVENT PERMITS THAT		
10	MAY BE ISSUED UNDER PARAGRAPH (1)(I) AND (III) OF THIS SUBSECTION, A		
11	CLASS 4 MARYLAND LIMITED WINERY MAY BE ISSUED A WINERY SPECIAL		
12	EVENT PERMIT FOR UNLIMITED USE FOR 1 DAY EACH WEEK AT A FARMERS'		
13	MARKET IN CHARLES COUNTY THAT IS LISTED ON THE FARMERS' MARKET		
14	DIRECTORY OF THE MARYLAND DEPARTMENT OF AGRICULTURE.
