A BILL ENTITLED

1 AN ACT concerning

2 **Charles County – Winery Special Event Permits – Farmers’ Markets**

3 FOR the purpose of authorizing the Office of the Comptroller to issue a winery special
4 event permit to a Class 4 Maryland limited winery in Charles County for
5 unlimited use for a certain amount of time each week at certain farmers’
6 markets in Charles County; and generally relating to the issuance of a winery
7 special event permit for use at a farmers’ market in Charles County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article 2B – Alcoholic Beverages**

21 2–101.

22 (u) (1) The Office of the Comptroller may issue a winery special event
23 permit to a licensed Class 4 Maryland limited winery, provided that:

1 (i) Except as provided in paragraphs (6), (7), (8), (9), (10), [and]
2 (11), AND **(12)** of this subsection, no more than 12 winery special event permits are
3 issued to the Class 4 Maryland limited winery in any given calendar year;

4 (ii) The permit does not exceed 3 consecutive days; and

5 (iii) Except as provided in paragraphs (6), (7), (8), (9), (10), [and]
6 (11), AND **(12)** of this subsection, no more than three winery special event permits are
7 issued in any calendar year to any given limited winery for use in the same political
8 subdivision.

9 **(12) IN ADDITION TO THE WINERY SPECIAL EVENT PERMITS THAT**
10 **MAY BE ISSUED UNDER PARAGRAPH (1)(I) AND (III) OF THIS SUBSECTION, A**
11 **CLASS 4 MARYLAND LIMITED WINERY MAY BE ISSUED A WINERY SPECIAL**
12 **EVENT PERMIT FOR UNLIMITED USE FOR 1 DAY EACH WEEK AT A FARMERS'**
13 **MARKET IN CHARLES COUNTY THAT IS LISTED ON THE FARMERS' MARKET**
14 **DIRECTORY OF THE MARYLAND DEPARTMENT OF AGRICULTURE.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 July 1, 2012.
