A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2010 – Prince George’s County**
3 **– La Vida Sana (Healthy Living Farm)**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2010
5 to extend the deadline for the Board of Directors of the Engaged Community
6 Offshoots, Inc. to present evidence that a matching fund will be provided;
7 requiring the Board of Public Works to expend or encumber the proceeds of the
8 loan by June 1, 2013; and generally relating to amending the Maryland
9 Consolidated Capital Bond Loan of 2010.

10 BY repealing and reenacting, with amendments,
11 Chapter 483 of the Acts of the General Assembly of 2010
12 Section 1(3) Item ZA02(BG) and Item ZA03(BD)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That:

19 (BG) La Vida Sana (Healthy Living Farm). Provide a grant equal to
20 the lesser of (i) \$50,000 or (ii) the amount of the matching fund
21 provided, to the Board of Directors of the Engaged Community
22 Offshoots, Inc. for the acquisition, design, and construction of
23 the Healthy Living Farm, located in Edmonston.
24 Notwithstanding Section 1(5) of this Act, the matching fund

 13 fund provided, to the Board of Directors of the Engaged
 14 Community Offshoots, Inc. for the acquisition, design, and
 15 construction of the Healthy Living Farm, located in
 16 Edmonston. Notwithstanding Section 1(5) of this Act, the
 17 matching fund may consist of real property, in kind
 18 contributions, or funds expended prior to the effective date of
 19 this Act **AND THE GRANTEE HAS UNTIL JUNE 1, 2013, TO**
 20 **PRESENT EVIDENCE THAT A MATCHING FUND WILL BE**
 21 **PROVIDED. NOTWITHSTANDING SECTION 1(7) OF THIS**
 22 **ACT, THE PROCEEDS OF THE LOAN MUST BE EXPENDED**
 23 **OR ENCUMBERED BY THE BOARD OF PUBLIC WORKS FOR**
 24 **THE PURPOSES PROVIDED IN THIS ACT NO LATER THAN**
 25 **JUNE 1, 2013** (Prince George’s County)..... 25,000
