## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2008 – Anne Arundel County –**  
3 **Goshen House**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2008  
5 to alter the requirement that the Board of Directors of the Goshen Farm  
6 Preservation Society, Inc. grant a certain historic easement to the Maryland  
7 Historical Trust; extending the deadline for the Board to present evidence that  
8 a matching fund will be provided; and generally relating to amending the  
9 Maryland Consolidated Capital Bond Loan of 2008.

10 BY repealing and reenacting, with amendments,  
11 Chapter 336 of the Acts of the General Assembly of 2008, as amended by  
12 Chapter 372 of the Acts of the General Assembly of 2010  
13 Section 1(3) Item ZA02(J)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
15 MARYLAND, That the Laws of Maryland read as follows:

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That:

20 (3) ZA02 LOCAL HOUSE INITIATIVES

21 (J) Goshen House. Provide a grant equal to the lesser of (i)  
22 \$150,000 or (ii) the amount of the matching fund provided, to  
23 the Board of Directors of the Goshen Farm Preservation  
24 Society, Inc. for the planning, design, construction, repair,

 2 Claire[, subject to a requirement that the grantee grant and

 4 Notwithstanding Section 1(5) of this Act, the matching fund  
 5 may consist of real property, in kind contributions, or funds  
 6 expended prior to the effective date of this Act and the grantee  
 7 must present evidence that a matching fund will be provided  
 8 by June 1, [2012] **2013** (Anne Arundel County) ..... 150,000

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 10 June 1, 2012.
