AMENDMENTS TO SENATE BILL 281, AS AMENDED

AMENDMENT NO. 1

On page 2 of the Judicial Proceedings Committee Amendments (SB0281/628575/1), in line 4 of Amendment No. 3, strike "OR".

On page 3 of the Judicial Proceedings Committee Amendments, in line 6 of Amendment No. 3, after "RETIREMENT" insert ".

(8) IF ACTING WITHIN THE SCOPE OF THE LICENSE, POSSESSION OR TRANSPORT BY A LICENSED PRIVATE DETECTIVE OR AGENCY LICENSED UNDER TITLE 13 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE OR A CERTIFIED SECURITY GUARD OR AGENCY LICENSED UNDER TITLE 19 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE IF THE INDIVIDUAL IS ACTING WITHIN THE SCOPE OF THEIR LICENSE AND HAS A PERMIT ISSUED UNDER TITLE 5, SUBTITLE 3 OF THE PUBLIC SAFETY ARTICLE; OR

(9) IF ACTING WITHIN THE SCOPE OF OFFICIAL BUSINESS, POSSESSION OR TRANSPORT BY AN EMPLOYEE OF AN ARMORED CAR AGENCY IF THE INDIVIDUAL IS ACTING WITHIN THE SCOPE OF EMPLOYMENT AND HAS A PERMIT ISSUED UNDER TITLE 5, SUBTITLE 3 OF THE PUBLIC SAFETY ARTICLE".

On page 9 of the Judicial Proceedings Committee Amendments, in line 8 of Amendment No. 6, strike "OR"; and in line 15, after "ORGANIZATION" insert ";

(3) IS CURRENTLY A LICENSED PRIVATE DETECTIVE OR AGENCY LICENSED UNDER TITLE 13 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE OR A CERTIFIED SECURITY GUARD OR AGENCY

(Over)

LICENSED UNDER TITLE 19 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE AND HAS A PERMIT ISSUED UNDER TITLE 5, SUBTITLE 3 OF THE PUBLIC SAFETY ARTICLE; OR

(4) IS AN EMPLOYEE OF AN ARMORED CAR AGENCY AND HAS A PERMIT ISSUED UNDER TITLE 5, SUBTITLE 3 OF THE PUBLIC SAFETY ARTICLE”.

AMENDMENT NO. 2

On page 37 of the bill, in line 20, strike “OR”.

AMENDMENT NO. 3

On page 16 of the Judicial Proceedings Committee Amendments, in line 4 of Amendment No. 19, strike “OR” and substitute:

“(4) IS CURRENTLY A LICENSED PRIVATE DETECTIVE OR AGENCY LICENSED UNDER TITLE 13 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE OR A CERTIFIED SECURITY GUARD OR AGENCY LICENSED UNDER TITLE 19 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE AND HAS A PERMIT ISSUED UNDER TITLE 5, SUBTITLE 3 OF THE PUBLIC SAFETY ARTICLE;

(5) IS AN EMPLOYEE OF AN ARMORED CAR AGENCY AND HAS A PERMIT ISSUED UNDER TITLE 5, SUBTITLE 3 OF THE PUBLIC SAFETY ARTICLE;
OR”;

and in line 5, strike “(4)” and substitute “(6)”.
