#### AMENDMENT NO. 1

On page 1, in line 2, strike "– Insurance Coverage"; and strike beginning with "establishing" in line 3 down through "duties" in line 5 and substitute "<u>specifying that</u> the duties to which the Sheriff of Washington County is required to assign special deputy sheriffs include certain duties; making the provision of county liability insurance to a special deputy sheriff discretionary, rather than mandatory; repealing a certain limitation on the provision of county liability insurance".

On page 2, in line 5, after "county" insert ", INCLUDING:

On page 3, in line 7, strike "(II)4" and substitute "(II)1".

### AMENDMENT NO. 3

On page 2, in line 11, strike "shall" and substitute "<u>MAY</u>"; and strike beginning with "only" in line 12 down through "sheriff" in line 13.
