18 (I) JANUARY 1 IF THE NOTICE OF ADOPTION IS PUBLISHED 19 IN THE REGISTER DURING THE PERIOD FROM SEPTEMBER 1 THROUGH 20 NOVEMBER 30, BOTH INCLUSIVE;
