### (II) SUNDAY, FROM 6 A.M. TO MIDNIGHT.

16 (b)It is unlawful for any licensee, his agent or employee, to sell any alcoholic 17beverages on any day between the hours of 2 o'clock a.m. and 6 o'clock a.m. and that part of any premises where alcoholic beverages are sold or displayed shall be open only 18 19during the hours of sale for alcoholic beverages set out in subsection (a) of this section. 20In the case of any on-sale class of license, all bottles and containers must be removed 21from the table on or before the hours of closing indicated in subsection (a) of this 22section. It is unlawful to sell any alcoholic beverages between midnight. Sunday, and 6 23o'clock a.m. Monday.

24(c) The hours established in this section for the sale of alcoholic beverages 25are hereby declared to be in accordance with Eastern Standard Time whenever such 26time is in effect or in accordance with daylight time whenever such time is in effect. 27Any person violating any of the provisions of this section shall be deemed guilty of a misdemeanor and upon trial and conviction shall be subjected to a fine of not less than 2829fifty dollars (\$50.00) nor more than two hundred and fifty dollars (\$250.00), or may be 30 confined in the county jail or in the house of correction for not less than sixty days, or 31 both, in the discretion of the court.

32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 33 July 1, 2013.
