## Procurement - Maryland Buy American Steel and Manufactured Goods Act

- 3 FOR the purpose of altering the Maryland Buy American Steel Act to include 4 American manufactured goods; requiring a public body to require that certain 5 contractors and subcontractors use or supply only American manufactured 6 goods under certain procurements; defining a term; providing for the application 7 of this Act; requiring a public body to give a certain notice; requiring the Board 8 of Public Works to adopt certain regulations regarding the granting of a 9 preference for the use of American manufactured goods; and generally relating 10 to the Maryland Buy American Steel and Manufactured Goods Act.

3	(a) In this subtitle the following words have the meanings indicated.
4	(B) "AMERICAN MANUFACTURED GOODS" MEANS GOODS FOR WHICH:
5 6	(1) ALL OF THE MANUFACTURING PROCESSES FOR THE FINAL PRODUCT TAKE PLACE IN THE UNITED STATES; AND
7 8 9	(2) ALL OF THE COMPONENTS OF THE FINAL PRODUCT ORIGINATE IN THE UNITED STATES ON ACCOUNT OF THE MANUFACTURING PROCESSES FOR THE COMPONENT, REGARDLESS OF THE ORIGIN OF THE SUBCOMPONENTS.

26 27	(a) Except as otherwise provided in this subtitle, a public body shall require a contractor or subcontractor to use or supply only American steel products AND AMERICAN MANUFACTURED GOODS in the performance of a contract for:

constructing or maintaining a public work; or

1	(2) buying or manufacturing machinery or equipment that:
2	(i) is composed of at least 10,000 pounds of steel products; and
3	(ii) is to be installed at a public work site.
4	(b) This section does not apply if the head of a public body determines that:
5 6	(1) the price of American steel products <b>OR AMERICAN MANUFACTURED GOODS</b> is not reasonable, as provided in § 17–304 of this subtitle;
7 8	(2) American steel products <b>OR AMERICAN MANUFACTURED GOODS</b> are not produced in sufficient quantity to meet the requirements of the contract; or
9 10	(3) the purchase of American steel products <b>OR AMERICAN MANUFACTURED GOODS</b> would be inconsistent with the public interest.
11 12 13	(c) The public body shall give notice of the requirement for American steel products AND AMERICAN MANUFACTURED GOODS in the invitation for bids or request for proposals.

15 16 17 18 19	The Board shall adopt regulations, in accordance with Title 10, Subtitle 1 of the State Government Article, stating that a bid or offered price of an American steel product <b>OR AN AMERICAN MANUFACTURED GOOD</b> shall be considered reasonable if it does not exceed the sum of the bid or offered price of a similar steel product <b>OR MANUFACTURED GOOD</b> of foreign origin, including duty, plus:

21 22 23	(2) 30% of that bid or offered price if the steel product <b>OR MANUFACTURED GOOD</b> is produced in a "substantial labor surplus area" as defined by the United States Department of Labor.

25 26 27 28	(a) Unless a public body is satisfied that a person has completed the work in full compliance with §§ 17–303 and 17–304 of this subtitle, the public body may not pay or authorize a payment for work subject to §§ 17–303 and 17–304 of this subtitle to a person under a contract.
29 30	(b) If a person receives a payment that should not have been made under subsection (a) of this section, the Attorney General may recover the portion of the

payment that is attributable to work that does not comply with §§ 17-303 and 17-304
