Morgan State University – Board of Regents – Length and Limitation of Terms

FOR the purpose of altering the length of time of the term of office of a member of the Board of Regents of Morgan State University; setting a limit on the number of terms that a member may serve; and generally relating to the terms of members of the Board of Regents of Morgan State University.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That the Laws of Maryland read as follows:

- **Article Education** 1516 14 - 10217 The government of the University is vested in the Board of Regents. (a) 18 (b) The Board of Regents consists of 15 members appointed by the Governor with the advice and consent of the Senate. 1920One member of the Board of Regents shall be a student in good (c) (1)academic standing at the University who: 21
- (i) Is at least 18 years old; and

A MEMBER MAY NOT 11 **(II)** SERVE MORE THAN TWO CONSECUTIVE TERMS OF 5 YEARS. 1213Except for the student member, at least 8 members of the Board of (2)Regents shall be residents of the State. 14A member appointed to fill a vacancy in an unexpired term serves 15(3)16 only for the remainder of that term and until a successor is appointed and gualifies. 17Each member of the Board of Regents: (e) (1)Serves without compensation; and 18 19 (2)Is entitled to reimbursement for expenses in accordance with the 20Standard State Travel Regulations. SECTION 2. AND BE IT FURTHER ENACTED, That a member of the Board 2122of Regents of Morgan State University who was appointed to the Board of Regents on 23or before December 31, 2012, may not serve, on completion of that term of office, more than one additional term of 5 years. 2425SECTION 3.
