## 2 Electrical Inspectors and Plumbing Inspectors – Master License Required

- 3 FOR the purpose of requiring a county or local government to employ as electrical 4 inspectors only individuals who hold, or have previously held within a certain 5 period of time under certain circumstances, a State license or local license, as 6 applicable, to provide electrical services as a master electrician or who are 7 certified by certain entities; requiring a county or local government to employ as 8 plumbing inspectors only individuals who hold a master plumber license issued 9 by certain entities; providing certain exceptions to certain requirements of this 10 Act; providing for the scope of certain provisions of this Act; providing for the application of this Act; providing for a delayed effective date; and generally 11 12 relating to licensing requirements for electrical inspectors and plumbing 13 inspectors.

- 27 (3) On termination of the appointment or employment of an individual 28 as a plumbing inspector, the Board shall reactivate the master plumber license, 29 journey plumber license, or limited license of an individual who is on inactive status, 30 without examination, if the individual:

[(d)] (E) The Board may impose a reasonable fee to cover the costs of conducting the continuing education courses under subsection (a) of this section.
SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any electrical inspector or plumbing inspector employed by a county or local government before the effective date of this Act.
SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effection $1, 2014$ .
