- 16 (a) (1) Except as provided in paragraphs (2), (3), (4), and (6) of this 17 subsection, a person may not hunt any game bird or mammal on Sundays.

- 20 (i) A person using State certified raptors to hunt game birds or 21 mammals during open season;
- (ii) An unarmed person participating in an organized fox chase
 to chase foxes;
