1 Provided that the provisions of § 10-415 of this subtitle are met (4) $\mathbf{2}$ and subject to paragraph (5) of this subsection, the Department may allow a person to 3 hunt deer on private property on the first Sunday of: The bow hunting season in November; and 4 (i) The deer firearms season. $\mathbf{5}$ (ii) 6 The Sunday deer hunting provisions under paragraph (4) of this (5)7subsection do not apply: 8 (i) In Baltimore, Howard, and Prince George's counties; and 9 (ii) In Baltimore City. A person who is 16 years of age or younger may hunt deer with a 10 (6)11 firearm on a Sunday through participation in the junior deer hunt established under § 1210–405(a) of this subtitle. SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency 13measure, is necessary for the immediate preservation of the public health or safety, 14has been passed by a yea and nay vote supported by three-fifths of all the members 15elected to each of the two Houses of the General Assembly, and shall take effect from 16

17 the date it is enacted.
