1 To promote the health, safety, and general welfare of the community, a 2 legislative body may regulate: 3 (1) the height, number of stories, and size of buildings and other 4 structures; the percentage of a lot that may be occupied; 5 (2)6 off-street parking; (3) 7 (4) the size of yards, courts, and other open spaces: 8 population density; and (5)the location and use of buildings, signs, structures, and land. 9 (6)10 **Article – Transportation** 8-605. 11 Along any State highway, the Administration may place signs, signals, or 12 (a) 13 markers to inform the traveling public of directions, distances, danger, or other information. 14 15 (b) Except as provided in paragraph (2) of this subsection, the Administration shall assume the full cost of installing and maintaining traffic signals 16 17 required at the intersection of a State highway with any municipal street or highway or at any other place along a State highway that is within the limits of any municipal 18 19 corporation. 20 (2)This subsection does not apply where the traffic signal primarily 21will serve traffic generated by a private development, such as an apartment complex, 22shopping center, industrial plant, or drive-in theater. 23 Signs, signals, and markers placed along any interstate highway shall 24conform to all applicable federal standards. 25 For the purpose of providing information to the driving public on (d) (1) 26 the availability of gas, food, lodging, camping, or attractions, the Administration may 27 place along State controlled access highways specific service signs, subject to the 28applicable federal standards. 29 The Administration shall adopt regulations governing (2)(i)

6 7 8 9 10 11	[(3)] (4) (i) A person that places or maintains a commercial sign within the right-of-way of a State highway in violation of this subsection is subject to a civil penalty not exceeding \$25 per commercial sign, which, if not paid after being cited and assessed by the Administration, county, or municipal corporation, may be recovered in a civil action in the District Court by the Administration or by the county or municipal corporation in which the commercial sign was located.
12 13 14 15	(ii) As to a county or a municipal corporation in which the commercial sign was located, the civil action in the District Court may be brought by the county attorney or, if the commercial sign was located in a municipal corporation, the municipal corporation attorney.

17 18	1. May enforce this subsection only by the issuance of a warning for the first 3 months after initiating a sign removal program; and
