- 4 FOR the purpose of requiring the Office of Student Financial Assistance to assist in $\mathbf{5}$ the repayment of certain higher education loans owed by certain recipients of a 6 Nancy Grasmick Teacher Award who receive certain degrees from certain 7 institutions of higher education in the State or outside the State; altering a 8 certain definition to authorize a certain student attending an institution of 9 higher education outside the State to qualify for a Walter Sondheim Jr. Public Service Summer Internship Scholarship; altering certain gualifications for 10 eligibility for a Walter Sondheim Jr. Public Service Summer Internship 11 12Scholarship; and generally relating to the Nancy Grasmick Teacher Award and the Walter Sondheim Jr. Public Service Summer Internship Scholarship 13 14Program.

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 21 MARYLAND, That the Laws of Maryland read as follows:
