12	professional land surveyors; altering certain requirements relating to the

- 1 (a) Except as otherwise provided in § 15–307.1 of this subtitle, an applicant 2 who otherwise qualifies for a license is entitled to be examined as provided in this section.
- 4 (b) The Board periodically shall give the examinations required under this subtitle to qualified applicants at the times and places that the Board determines.
- 6 (c) The Board shall give each qualified applicant notice of the time and place 7 of examination.
- 8 (d) As provided for applicants for a license to practice land surveying under § 9 15–305 of this subtitle, the Board shall give the following [2] separate examinations:
- 10 (1) [a written examination in] the fundamentals of [land] surveying; 11 [and]
- 12 (2) [a written examination in] the principles and practice of [land] 13 surveying; AND
