1 (c) (1) [An] SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION, AN 2 absentee ballot shall be deemed timely received if it is received in accordance with the 3 regulations and guidelines established by the State Board.

4 (2) [An] SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION, AN 5 absentee ballot that is received after the deadline specified by the regulations and 6 guidelines may not be counted.

7 (3) AN ABSENTEE BALLOT THAT IS RETURNED TO A LOCAL BOARD 8 BY AN ABSENT UNIFORMED SERVICES VOTER OR AN OVERSEAS VOTER, AS 9 THOSE TERMS ARE DEFINED IN THE FEDERAL UNIFORMED AND OVERSEAS 10 CITIZENS ABSENTEE VOTING ACT, SHALL BE CONSIDERED TIMELY IF THE 11 ABSENTEE BALLOT IS:
