A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Trust Act**

3 FOR the purpose of repealing and revising certain provisions of law relating to trusts;
4 providing that this Act may be cited as the Maryland Trust Act; providing for
5 the scope of this Act; providing for the construction of this Act; providing for the
6 designation of the principal place of administration for a trust; establishing a
7 standard for whether notice to a person under this Act must be accomplished
8 and how notice may be waived; providing for the role of a court in the
9 administration of a trust; providing that a certain trustee and the beneficiaries
10 of a trust are subject to the jurisdiction of the courts of this State under certain
11 circumstances; establishing standards for judicial review of the discretion of a
12 trustee; providing for the consent of a person that may represent and bind
13 another person under this Act; providing that the holder of a certain qualified
14 power of appointment may represent and bind a certain person; providing that a
15 certain person may represent a certain other person with respect to a particular
16 question or dispute; authorizing a court to appoint a representative for a certain
17 interest in certain circumstances; providing methods and requirements for
18 creating a trust under this Act; establishing the method by which a trust for
19 care of an animal may be created; providing certain rules for a certain
20 noncharitable trust; providing for the modification or termination of a trust;
21 authorizing a court to reform the terms of a certain trust; authorizing a court to
22 modify the terms of a trust in a certain manner; authorizing a court to authorize
23 a creditor or assignee of a beneficiary to reach a certain beneficiary's interest by
24 attachment of certain distributions; establishing the rights of a certain
25 beneficiary and a certain creditor to a trust interest that is subject to a
26 discretionary distribution provision; providing that certain actions may not be
27 taken with respect to a beneficial interest that is subject to a support provision;
28 providing for the treatment of a spendthrift provision in a trust; authorizing a
29 court to authorize a creditor or assignee of the beneficiary to attach certain
30 distributions in certain circumstances; providing for circumstances to create a
31 certain general power of appointment or a power of withdrawal; establishing

1 rules for the claim of a certain creditor; establishing that trust property is not
2 subject to certain personal obligations of the trustee; prohibiting a creditor from
3 taking certain actions to compel a certain distribution; providing for the
4 transfer to trust of property held by tenants by the entirety; establishing the
5 capacity of a settlor of a revocable trust to take certain actions; providing the
6 manner by which the settlor may revoke or amend a revocable trust;
7 establishing the rights of certain beneficiaries; establishing the method by
8 which a person designated as trustee accepts or rejects the trusteeship;
9 requiring a trustee to give a certain bond under certain circumstances;
10 providing for circumstances in which a vacancy occurs in a cotrusteeship;
11 authorizing a trustee to resign in certain circumstances; providing grounds for
12 the removal of a trustee; establishing the duties and powers of a trustee who
13 has resigned or been removed; providing that certain trustees are entitled to
14 certain commissions and certain reimbursements; authorizing certain persons
15 to exercise certain trust and fiduciary powers; prohibiting a certain person from
16 serving as a trustee in certain circumstances; requiring a certain trustee to
17 perform certain duties; authorizing a trustee to delegate certain duties and
18 powers in certain circumstances; authorizing a certain trustee to follow a
19 certain direction of the settlor; establishing that certain persons shall be
20 considered advisers and fiduciaries in certain circumstances; requiring a certain
21 trustee to act in accordance with the directions of a certain adviser in certain
22 circumstances; providing that a certain trustee does not have certain liabilities
23 and duties; providing that a certain adviser has the power to perform certain
24 actions; requiring a trustee to take certain steps to take control of and protect
25 the trust property, with a certain exception; requiring the trustee to do certain
26 record keeping and to keep certain property in a certain manner; requiring a
27 trustee to take certain steps in certain circumstances; requiring the trustee to
28 respond promptly to a certain request for information; requiring a trustee to
29 provide certain notice to certain beneficiaries; requiring a trustee to send a
30 certain report to certain persons; prohibiting a trustee from exercising certain
31 powers; authorizing a trustee to exercise certain powers in certain
32 circumstances; providing for damages for which a certain trustee is or is not
33 liable; authorizing a court to award costs and expenses in a certain judicial
34 proceeding; providing that a certain trustee is not liable for a certain loss;
35 providing that a certain term of a trust is unenforceable in certain
36 circumstances; providing for the effect of an exculpatory term in a trust;
37 providing for the liability of a trustee for breach of trust in certain
38 circumstances; establishing limitations of personal liability of the trustee in
39 certain circumstances; authorizing a trustee to furnish a certification of trust in
40 certain circumstances; providing that the provisions of this Act relating to the
41 use of electronic records and signatures conform to a certain federal statute;
42 providing for the severability of provisions in this Act if held invalid; providing
43 for the application of this Act to certain trusts and judicial proceedings; defining
44 certain terms; and generally relating to trusts.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article – Estates and Trusts**

23 11–102.

24 (b) Subject to §§ 4–409 of this article and 11–103 of this subtitle, the
 25 common-law rule against perpetuities as now recognized in the State is preserved, but
 26 the rule does not apply to the following:

27 (12) A trust created under [§ 14–112] § 14.5–407 of this article to
 28 provide for the care of an animal alive during the lifetime of the settlor; or

29 [Subtitle 1. General Provisions.]

30 [14–101.

31 A court having equity jurisdiction has general superintending power with
 32 respect to trusts. The provisions of Titles 1 through 13 of this article do not affect or
 33 supersede this power.]

34 [14–102.

1 In the absence of express language to the contrary, the rules contained in
2 §§ 1-202, 1-203, 1-204, 1-205, 1-206, 1-207, 1-208, 1-209, and 1-210.1 of this article
3 shall be applied in construing the terms of an inter vivos trust. Whenever any of those
4 statutory sections refer to a “will,” “estate,” or similar terms relevant primarily to wills
5 and estates or the takers under them, the terms shall be modified to mean “trust
6 instrument,” “trust,” or similar terms to reflect the application of the principles of
7 those sections to inter vivos trusts.]

9 (a) (1) A testamentary trustee and trustee of any other trust whose duties
10 comprise the collection and distribution of income from property held under a trust
11 agreement or the preservation and distribution of the property are entitled to
12 commissions provided for in this section for their services in administering the trusts.
13 The amount and source of payment of commissions are subject to the provisions of any
14 valid agreement. Any court having jurisdiction over the administration of the trust
15 may increase or diminish commissions for sufficient cause or may allow special
16 commissions or compensation for services of an unusual nature.

17 (2) A schedule of increased rates of income commissions and corpus
18 commissions may be charged by a trustee whose activities are subject to State or
19 federal supervision or who is a member of the Maryland Bar and who has:

20 (i) Filed a schedule of the increased rates of commissions with
21 an appropriate agency; and

22 (ii) Given notice of the scheduled rates or revisions to the
23 ascertained beneficiaries of the affected trust.

24 (3) The notice required under paragraph (2) of this subsection shall be
25 delivered to the beneficiaries personally or sent to the beneficiaries at their last known
26 address by registered or certified mail, postage prepaid, return receipt requested.

27 (b) Accounting from July 1, 1981, whether or not the trust was in existence
28 at that time, income commissions are:

29 (1) 6 percent upon all income from real estate, ground rents, and
30 mortgages collected in each year; and

31 (2) 6 1/2 percent upon the first \$10,000 of all other income collected in
32 each year, 5 percent upon the next \$10,000, 4 percent upon the next \$10,000, and 3
33 percent upon any remainder.

34 Income commissions shall be paid from and chargeable against income. Income
35 collected includes any portion of income payable to a trustee but withheld by the payor
36 in compliance with any revenue law.

1 (c) Accounting from July 1, 1981, whether or not the trust was in existence
2 at that time, commissions are payable at the end of each year upon the fair value of
3 the corpus or principal held in trust at the end of each year as follows:

4 (1) Four tenths of one percent on the first \$250,000;

5 (2) One fourth of one percent on the next \$250,000;

6 (3) Three twentieths of one percent on the next \$500,000; and

7 (4) One tenth of one percent upon any excess. Corpus commissions
8 shall be paid out of and chargeable against the corpus.

9 If a trust terminates, with respect to all or any part of the corpus held in trust
10 in the course of any year, the commission for that year shall be reduced or prorated
11 according to the part of the year elapsed and the amount of corpus as to which the
12 trust terminates, and be chargeable, for such part of a year (and with respect to any
13 such part of the corpus) at such termination of the trust, upon the then value of the
14 corpus.

15 (d) For selling real or leasehold property, a commission upon the proceeds of
16 the sale is payable at the rate allowed by rule of court or statute to trustees appointed
17 to make sales under decrees or orders of the circuit court for the county where the real
18 or leasehold property is situated, or if the property is located outside Maryland, for
19 selling similar property in the county where the trust is being administered. The
20 commission is payable from the proceeds of the sale when collected.

21 (e) Upon the final distribution of any trust estate, or portion of it, an
22 allowance is payable commensurate with the labor and responsibility involved in
23 making the distribution, including the making of any division, the ascertainment of
24 the parties entitled, the ascertainment and payment of taxes, and any necessary
25 transfer of assets. The allowance is subject to revision or determination by any circuit
26 court having jurisdiction. In the absence of special circumstances the allowance shall
27 be equal to one half of one percent upon the fair value of the corpus distributed.

28 (f) In determining what is a single trust for the application of the rates
29 provided in this section, all property held undivided under the terms of the will or
30 other instrument creating the trust shall be considered as a single trust. After any
31 shares have been set apart or divided, to be held in separate trust, each separate trust
32 set apart shall be considered as a single trust.

33 (g) (1) Instead of the rates of income commissions and corpus
34 commissions provided in subsections (b) and (c) of this section, a trustee may charge
35 reasonable compensation calculated in accordance with a schedule of rates previously
36 filed by the trustee with the appropriate agency as specified in paragraph (2) of this
37 subsection, if the trustee is:

1 (i) A financial institution whose activities are subject to
2 supervision by this State or the federal government or which is an instrumentality of
3 the United States; or

4 (ii) A member of the Bar of this State.

5 (2) A trustee shall file a schedule of rates under this subsection as
6 follows:

7 (i) For a savings and loan association, with the State Director
8 of the Division of Savings and Loan Associations;

9 (ii) For all other trustees, including attorneys and State
10 chartered and national banks, with the Commissioner of Financial Regulation; and

11 (iii) For a trustee administering an estate under the jurisdiction
12 of a court, also with the trust clerk of the court.

13 (3) In a trust involving multiple trustees and more than one of the
14 trustees may be entitled to file a schedule of increased rates, the controlling schedule
15 will be the schedule filed by the trustee having custody of the assets and maintaining
16 records of the trust.

17 (4) Whenever a trustee files a schedule of increased rates under this
18 subsection, the trustee shall give notice to the ascertained beneficiaries of each
19 affected trust. The notice required under this paragraph shall be delivered to the
20 beneficiaries personally or sent to the beneficiaries at their last known address by
21 registered or certified mail, postage prepaid, return receipt requested. Any beneficiary
22 of a trust who objects to the schedule of rates to be charged to that trust, after
23 notifying the trustee of the objection, may petition the appropriate circuit court to
24 review the reasonableness of the rates to be charged. The notice required by this
25 paragraph shall include a clear statement of the rights and procedures available to
26 beneficiaries under this subsection. If the court finds that the rates in the schedule are
27 unreasonable for the current fiscal year of the particular trust, the trustee's
28 commissions for that trust for that fiscal year shall be limited to the rates charged that
29 trust during the previous fiscal year.

30 (5) If a trustee does not file a schedule of rates with the appropriate
31 agency under paragraph (2)(i) or (ii) of this subsection and does not notify ascertained
32 beneficiaries as provided in paragraph (4) of this subsection, the trustee is limited to
33 charging the rates set forth in subsections (b) and (c) of this section.

34 (h) An individual trustee who is not authorized to file a schedule of increased
35 rates under this section is limited to charging the rates set forth in subsections (b) and
36 (c) of this section unless the trustee petitions the circuit court for the county where the
37 trustee is located and obtains approval of an increase in fee after giving notice of such
38 action to the ascertained beneficiaries of the trusts affected.

1 (i) The schedule of increased rates of income commissions and corpus
2 commissions which trustees are authorized to charge as provided in subsection (g) of
3 this section is not applicable to guardians.

4 (j) The legal and court costs incurred by the trustee pursuant to any court
5 review under subsection (g)(4) or (h) of this section shall be charged against trustees'
6 fees and may not be assumed by the trust or the beneficiaries.]

8 A judge of any court established under the laws of the State or the United
9 States or any clerk of court or register of wills, unless he is the surviving spouse of the
10 grantor of the trust, or is related to the grantor within the third degree, may not serve
11 as a trustee of any inter vivos or testamentary trust created by an instrument and
12 executed in Maryland by the grantor or any trustee, administered in the State or
13 governed by the laws of the State, unless he was actually serving as a trustee of the
14 trust on December 31, 1969.]

16 In the absence of actual knowledge or of reasonable cause to inquire as to
17 whether a trustee is improperly exercising his power, a person dealing with a trustee
18 need not inquire whether a trustee is properly exercising his power, and is protected
19 as if the trustee properly exercised the power. A person need not see to the proper
20 application of trust assets paid or delivered to a trustee.]

21 [14-106.

22 (a) In this section, "beneficiary" means a person in being who has a vested
23 interest, whether:

24 (1) Possessory or not; and

25 (2) Subject to divestment or not.

26 (b) (1) Subject to the provisions of paragraph (2) of this subsection, on
27 petition by a trustee, personal representative, beneficiary, or a party in interest, after
28 notice as the court may direct to the trustees, personal representatives, beneficiaries,
29 and parties in interest, and for good cause shown, a court may:

30 (i) Divide a trust into 2 or more separate trusts; or

31 (ii) Consolidate 2 or more trusts into a single trust.

32 (2) A court may divide a trust or consolidate trusts:

1 (i) On terms and conditions as the court considers appropriate;
2 and

3 (ii) If the court is satisfied that a division of a trust or
4 consolidation of trusts will not defeat or materially impair:

5 1. The accomplishment of trust purposes; or

6 2. The interests of the beneficiaries.

7 (3) A court may pass orders that the court considers proper or
8 necessary to protect the interests of a:

9 (i) Trustee;

10 (ii) Personal representative;

11 (iii) Beneficiary; or

12 (iv) Party in interest.

13 (c) This section applies to trusts:

14 (1) Whenever created;

15 (2) Whether inter vivos or testamentary;

16 (3) Created by the same or different instruments;

17 (4) Created by the same or different persons; and

18 (5) Regardless of where created or administered.

19 (d) This section may not be construed to limit the right of a trustee or
20 personal representative to divide a trust or consolidate trusts, without an order of a
21 court, in accordance with the applicable provisions of the governing instrument.]

22 [14–107.

23 (a) (1) In this section the following words have the meanings indicated.

24 (2) (i) “Beneficiary” means an ascertainable person who has a
25 present or future interest in a trust estate.

26 (ii) “Beneficiary” includes:

1 (vi) A statement that the effective date of the termination shall
2 be at least 90 days after the date on which notice under paragraph (1) of this
3 subsection has been received by each cotrustee and each beneficiary;

4 (vii) A statement of the reasons for termination of the trust;

5 (viii) The approximate amount and the manner of calculation of
6 each distribution of the trust estate; and

7 (ix) A statement of the right to object and the procedures to
8 follow under subsection (d) of this section.

9 (d) (1) A person entitled to notice under subsection (c) of this section who
10 objects to the termination of a trust shall send written objection to the termination.

11 (2) The written objection shall be personally delivered or mailed by
12 certified mail, postage prepaid, return receipt requested, within 60 days after the date
13 on which notice that is sent under subsection (c)(1) of this section is received by the
14 objecting party, to the corporate fiduciary trustee proposing to terminate the trust at
15 the address in the notice.

16 (e) (1) If no beneficiary or cotrustee delivers a timely objection in
17 accordance with the provisions of subsection (d) of this section, the trust shall be
18 terminated and the trust estate shall be distributed in accordance with the provisions
19 of subsection (f) of this section.

20 (2) If a beneficiary or cotrustee delivers a timely written objection in
21 accordance with the provisions of subsection (d) of this section, the trust shall not be
22 terminated unless the objection is withdrawn in writing by the objecting party within
23 90 days after receipt of the notice by the objecting party.

24 (f) (1) A trust estate that is terminated under this section shall be
25 distributed in any manner unanimously agreed upon by all beneficiaries.

26 (2) (i) If the beneficiaries do not unanimously agree to a manner of
27 distribution, the distribution shall be made in accordance with the provisions of this
28 paragraph.

29 (ii) A beneficiary who has a present interest in the trust estate
30 shall receive an amount equal to the present value of an annuity equal to the
31 beneficiary's proportionate share of the average net annual income of the trust as of its
32 last 3 anniversary dates for a term equal to the life expectancy of the beneficiary, at
33 the interest rate for valuing vested benefits provided by the Pension Benefit
34 Guarantee Corporation for the month immediately preceding the date of which the
35 notice under subsection (c)(1) of this section is sent.

1 (iii) The amount of the trust estate remaining after distribution
2 to beneficiaries having a present interest in the trust estate shall be distributed to any
3 beneficiaries having a future interest in the trust estate in whatever proportions are
4 provided for under the terms of the governing instrument under which the trust was
5 created.

6 (g) The existence of spendthrift or similar protective language in the
7 governing instrument under which the trust was created may not prevent termination
8 under this section.

9 (h) All expenses incurred by the trustee incident to the termination of a trust
10 under this section shall be borne by the trust estate.

11 (i) A distribution to a minor beneficiary shall be made to the minor's
12 custodian under the Maryland Uniform Gifts to Minors Act or the Maryland Uniform
13 Transfers to Minors Act.

14 (j) This section may not be construed to limit the right of any trustee to
15 terminate a trust in accordance with applicable provisions of the governing instrument
16 under which the trust was created.

17 (k) A trust may be terminated under this section if:

18 (1) The trustee has determined that termination of the trust is in the
19 best interests of the beneficiaries; and

20 (2) The governing instrument does not expressly prohibit termination
21 of the trust regardless of its size.

22 (l) A trust may not be terminated under this section if:

23 (1) The provisions of the governing instrument make the trust eligible
24 to qualify for the marital deduction for United States estate tax or for United States
25 gift tax purposes under the Internal Revenue Code, unless all beneficiaries agree that
26 all of the trust estate shall be distributed to the spouse of the creator of the trust; or

27 (2) The provisions of the governing instrument make the trust qualify,
28 in whole or in part, for a charitable deduction for United States estate tax, United
29 States gift tax, or United States income tax purposes under the Internal Revenue
30 Code, unless all beneficiaries agree that all of the trust estate shall be distributed to
31 one or more beneficiaries that qualify for the charitable deduction under the Internal
32 Revenue Code.]

33 [14–108.

34 (a) (1) In this section, “environmental law” means a federal, State, or local
35 law, rule, regulation, or ordinance that relates to the protection of the environment.

1 (2) “Environmental law” includes Title 16 of the Environment Article.

2 (b) (1) To comply with an environmental law, a trustee may:

3 (i) Inspect property held by the trustee, including any type of
4 interest in a sole proprietorship, partnership, limited liability company, or corporation,
5 and any assets owned by a sole proprietorship, partnership, limited liability company,
6 or corporation, to determine compliance with an environmental law and respond to an
7 actual or potential environmental liability relating to the property;

8 (ii) Before or after the initiation of a claim or a governmental
9 enforcement action, take action necessary to prevent, abate, or otherwise remedy an
10 actual or potential environmental liability that affects a trust asset;

11 (iii) Settle or compromise at any time a claim against the trust
12 based on an alleged environmental liability that may be asserted by any person; and

13 (iv) Pay from the trust the costs of an inspection, review, study,
14 abatement, response, cleanup, or other remedial action that involves an environmental
15 liability.

16 (2) If a trustee acts prudently and in good faith, the trustee is not
17 liable to a person with an interest in assets of the trust held by the trustee for a
18 decrease in the value of the assets for taking action under this subsection or otherwise
19 taking action to comply with an environmental law or reporting requirement.

20 (3) Acceptance by the trustee of property or failure by the trustee to
21 take action under this subsection does not imply that there is or may be liability under
22 an environmental law with respect to any property.]

23 [14–109.

24 (a) None of the following powers conferred upon a trustee by the governing
25 instrument may be exercised by that trustee:

26 (1) The power to make any discretionary distributions of either
27 principal or income to or for the benefit of the trustee in the trustee’s individual
28 capacity, unless limited by an ascertainable standard relating to the trustee’s health,
29 education, support and maintenance, as defined in 26 U.S.C. §§ 2041 and 2514 and the
30 Treasury regulations promulgated under those sections;

31 (2) The power to make any discretionary distributions of either
32 principal or income to satisfy any of the trustee’s legal obligations in the trustee’s
33 individual capacity for support or other purposes;

1 (3) The power to make discretionary allocations in the trustee's favor
2 of receipts or expenses as between income and principal;

3 (4) Any power, in whatever capacity held, to remove or replace any
4 trustee who holds any of the powers proscribed in this subsection; or

5 (5) The power to exercise any of the powers proscribed in this
6 subsection with regard to a beneficiary other than the trustee to the extent that such
7 beneficiary could exercise a similar prohibited power in connection with a trust which
8 benefits the trustee.

9 (b) If a trustee is prohibited by subsection (a)(1) of this section from
10 exercising a power conferred upon the trustee, the trustee may nevertheless exercise
11 the power except that the trustee's exercise of that power shall be limited by an
12 ascertainable standard relating to the trustee's health, education, support and
13 maintenance, as defined in 26 U.S.C. §§ 2041 and 2514 and the Treasury regulations
14 promulgated under those sections.

15 (c) If the governing instrument contains a power described under subsection
16 (a) of this section, and there is no trustee who can exercise such power, upon
17 application of any party in interest, a court may appoint a trustee who is not otherwise
18 disqualified under this section to exercise any such power during the period of time
19 that the court designates.

20 (d) This section does not apply if:

21 (1) As a result of application of subsection (a) of this section, a marital
22 deduction for the trust property would not be allowed to a spouse who is a trustee and
23 to whom a marital deduction would otherwise be allowed under the Internal Revenue
24 Code; or

25 (2) The trust is revocable or amendable, during the time that the trust
26 remains revocable or amendable.

27 (e) (1) In this subsection, "parties in interest" means:

28 (i) Each trustee then serving; and

29 (ii) Each income beneficiary and remainder beneficiary then in
30 existence or, if such beneficiary has not attained majority or is otherwise
31 incapacitated, the beneficiary's legal representative under applicable law or the
32 beneficiary's donee under a durable power of attorney that is sufficient to grant such
33 authority.

34 (2) Subject to the provisions of subsection (d) of this section, this
35 section applies to:

1 (i) Any trust created under a governing instrument executed
2 after September 30, 1995, unless the terms of the governing instrument provide
3 expressly that this section does not apply; and

4 (ii) Any trust created under a governing instrument executed
5 before October 1, 1995, unless all parties in interest elect affirmatively not to be
6 subject to the application of this section on or before the later of October 1, 1998, or 3
7 years after the date on which the trust becomes irrevocable.

8 (f) The affirmative election required under subsection (e) of this section must
9 be made through a written declaration signed by the interested person and delivered
10 to the trustee.]

11 [14–110.

12 (a) The following persons may exercise trust or fiduciary powers in this
13 State:

14 (1) An individual;

15 (2) A trust company as defined in § 1–101 of this article;
