- 3 FOR the purpose of requiring the Department of Public Safety and Correctional 4 Services to transmit weekly a certain registry and a certain listing to the State 5 Department of Education in a certain format; prohibiting a registered sex 6 offender from entering onto certain real property on which a home is located where certain informal child care is provided or will be provided; requiring 7 8 certain adults known by the State Department of Education to be residing in 9 certain locations to obtain a certain criminal history records check; requiring an 10 adult known to be residing in an informal child care provider's home to obtain a 11 criminal history records check; requiring certain informal child care providers to obtain a criminal history records check; requiring the State Department of 12 13 Education to conduct a certain cross-reference certain cross-references; providing for a delayed effective date; and generally relating to criminal history 14 records checks of individuals who care for or supervise children. 15
