- 4 (C) A PERSON MAY NOT USE, SELL, MANUFACTURE, POSSESS, OR 5 DISTRIBUTE SYNTHETIC CANNABINOIDS.
- 6 (D) (1) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A 7 MISDEMEANOR AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT 8 EXCEEDING 1 YEAR OR A FINE NOT EXCEEDING \$1,000 OR BOTH.
- 9 (2) A PERSON CONVICTED OF THE USE OR POSSESSION OF LESS 10 THAN 10 GRAMS OF SYNTHETIC CANNABINOIDS IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 90 DAYS OR A FINE NOT EXCEEDING \$500 OR BOTH.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
