1 AN ACT concerning

2 Washington County – Special Deputy Sheriffs – Insurance Coverage

3 FOR the purpose of establishing that county liability insurance shall be provided to a special deputy sheriff in Washington County only when the special deputy 4 $\mathbf{5}$ sheriff is performing certain duties; establishing that designation as a special 6 deputy sheriff does not authorize the special deputy sheriff to perform law 7 enforcement duties outside the special deputy sheriff's jurisdiction except under 8 certain circumstances; establishing that a special deputy sheriff is under the 9 authority of the Sheriff of Washington County while the special deputy sheriff is performing certain duties; and generally relating to special deputy sheriffs in 10 Washington County. 11

7 (III) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II)4 OF THIS 8 PARAGRAPH, DESIGNATION AS A SPECIAL DEPUTY SHERIFF DOES NOT 9 AUTHORIZE THE SPECIAL DEPUTY SHERIFF TO PERFORM LAW ENFORCEMENT 10 DUTIES OUTSIDE THE SPECIAL DEPUTY SHERIFF'S JURISDICTION.

(IV) A SPECIAL DEPUTY SHERIFF IS UNDER THE AUTHORITY
OF THE SHERIFF OF WASHINGTON COUNTY WHILE THE SPECIAL DEPUTY
SHERIFF IS PERFORMING DUTIES AS A SPECIAL DEPUTY SHERIFF.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effectOctober 1, 2013.
