41 finance the construction of or improvements to certain Baltimore City public
42 school facilities in accordance with a certain 10-year plan for Baltimore City
43 Public Schools and subject to certain limitations; specifying that the Authority
44 and the Baltimore City Board of School Commissioners shall be responsible for
45 certain public school facilities construction and improvement projects;
46 prohibiting the interference with or limitation of the powers of the Authority

11 funds under certain circumstances; requiring the State Comptroller to withhold
12 the distribution of certain income tax revenues to Baltimore City under certain
13 circumstances; requiring the Authority to direct the State Comptroller to
14 withhold certain payments to the Baltimore City Board of School
15 Commissioners and instead deposit that money into a certain fund under
16 certain circumstances; requiring a certain joint report on or before a certain
17 date year; providing for certain requirements for the Baltimore City Board of
18 School Commissioners regarding certain buildable sites and certain operational
