19 20	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

23 24	Except as otherwise provided in this title, a person may not practice, attempt to practice, or offer to practice medicine in this State unless licensed by the Board.

- 2 (a) Unless authorized to practice medicine under this title, a person may not 3 represent to the public, by description of services, methods, or procedures, or 4 otherwise, that the person is authorized to practice medicine in this State.
- 5 (b) Except as otherwise provided in this article, a person may not use the 6 words or terms "Dr.", "doctor", "physician", "D.O.", or "M.D." with the intent to 7 represent that the person practices medicine, unless the person is:
- 8 (1) Licensed to practice medicine under this title;
- 9 (2) A physician licensed by and residing in another jurisdiction, while 10 engaging in consultation with a physician licensed in this State;
- 11 (3) A physician employed by the federal government while performing 12 duties incident to that employment;
- 13 (4) A physician who resides in and is licensed to practice medicine by 14 any state adjoining this State and whose practice extends into this State; or
- 15 (5) An individual in a postgraduate medical program that is approved by the Board.
- 17 (c) An unlicensed individual who acts under § 14–302 or § 14–306 of this 18 title may use the word "physician" together with another word to describe the 19 occupation of the individual as in phrases such as "physician's assistant" or 20 "physician's aide".

- (a) (1) Except as provided in paragraph (4) of this subsection, a person who violates any provision of this subtitle is guilty of a misdemeanor and on conviction is subject to a fine not exceeding \$5,000 or imprisonment not exceeding 5 years or both.
- 26 (4) Except as provided in paragraph (5) of this subsection, a person 27 who violates § 14–601 **OR § 14–602** of this subtitle is:
- 28 (i) Guilty of a felony and on conviction is subject to a fine not exceeding \$10,000 or imprisonment not exceeding 5 years or both; and
- 30 (ii) Subject to a civil fine of not more than \$50,000 to be levied 31 by the Board.
