- 1 (I) ANY PHYSICAL CHANGE AT A SITE, INCLUDING 2 FABRICATION, ERECTION, INSTALLATION, OR DEMOLITION; OR
- 3 (II) THE ENTRY INTO A BINDING AGREEMENT OR
- 4 CONTRACTUAL OBLIGATION TO PURCHASE EQUIPMENT EXCLUSIVELY FOR USE
- 5 IN CONSTRUCTION IN THE STATE OR TO UNDERTAKE A PROGRAM OF ACTUAL
- 6 CONSTRUCTION IN THE STATE THAT CANNOT BE CANCELED OR MODIFIED
- 7 WITHOUT SUBSTANTIAL LOSS TO THE OWNER OR OPERATOR OF THE PROPOSED
