A BILL ENTITLED

1 AN ACT concerning

2 **Environment – Wetlands and Waterways Authorizations – Installation of**
3 **Personal Watercraft Lifts**

4 FOR the purpose of authorizing a person to install a certain number of personal
5 watercraft lifts in addition to a certain number of boat lifts or hoists under a
6 minor wetlands and waterways project authorization from the Department of
7 the Environment; establishing a certain application fee for an authorization to
8 install a personal watercraft lift; and generally relating to wetlands and
9 waterways authorizations.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article – Environment**

23 5–203.1.

24 (a) (8) “Minor project” means a project that:

1 (i) Proposes to permanently impact less than 5,000 square feet
2 of wetlands or waterways, including the 100-year floodplain; and

3 (ii) Does not meet the definition of a major project.

4 (b) (4) Subject to paragraph (5) of this subsection, an application for the
5 following minor projects shall be accompanied by the following application fees:

6 (i) Installation of one boat [lift, hoist, or personal watercraft
7 lift] **LIFT OR HOIST** at each authorized slip, not exceeding four slips, lifts, or hoists
8 per pier..... \$300;

9 (ii) **INSTALLATION OF ONE PERSONAL WATERCRAFT LIFT**
10 **AT EACH AUTHORIZED SLIP, NOT EXCEEDING TWO SLIPS OR PERSONAL**
11 **WATERCRAFT LIFTS PER PIER \$300;**

12 [(ii)] (iii) Installation of a maximum of six mooring
13 pilings..... \$300;

14 [(iii)] (iv) In-kind repair and replacement of
15 structures..... \$300;

16 [(iv)] (v) Installation of a fixed or floating platform on an
17 existing pier where the total platform area does not exceed 200 square
18 feet..... \$300;

19 [(v)] (vi) Construction of a nonhabitable structure that
20 permanently impacts less than 1,000 square feet, such as a driveway, deck, pool, shed,
21 or fence..... \$300;

22 [(vi)] (vii) Replacement of an existing bulkhead where the
23 replacement bulkhead does not exceed more than 18 inches channelward of the
24 existing structure..... \$500; and

25 [(vii)] (viii) In-kind repair and replacement of existing
26 infrastructure..... \$500.

27 (5) The Department may not require an application fee for:

28 (i) The installation of a [boatlift] **BOAT LIFT**, hoist, or personal
29 watercraft lift on existing pilings; or

30 (ii) If the existing structure is functional and there is no
31 increase in the original length, width, height, or channelward encroachment
32 authorized under § 16-202, § 16-302, or § 16-307 of this article, the routine
33 maintenance, repair, or replacement of:

- 1 1. A highway structure;
- 2 2. A pier;
- 3 3. A boathouse;
- 4 4. A structure on a pier;
- 5 5. A bulkhead;
- 6 6. A revetment;
- 7 7. A tidal impoundment dike;
- 8 8. A water control structure;
- 9 9. An aboveground transmission facility;
- 10 10. An agricultural drainage ditch; or
- 11 11. A highway drainage ditch.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
13 July 1, 2013.
