2 ***Baltimore City – Video Lottery Operation ~~Licensees~~ Licensee – Employee***
3 ***Data Collection***

4 FOR the purpose of requiring a certain video lottery operation licensee to compile
5 certain data concerning ~~its~~ certain employees and submit the data to the State
6 Lottery and Gaming Control Commission on or before a certain date; requiring
7 the Commission to submit a certain report to the General Assembly and certain
8 other persons within a certain time; and generally relating to a certain video
9 lottery operation ~~licensees~~ licensee and the State Lottery and Gaming Control
10 Commission.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
8 MARYLAND, That the Laws of Maryland read as follows:

9 **Article – State Government**

10 9–1A–01.

11 (a) In this subtitle the following words have the meanings indicated.

12 (k) “Commission” means the State Lottery and Gaming Control Commission.

13 9–1A–23.

14 **(D) (1) ~~ON OR BEFORE MARCH 31 OF EACH YEAR~~ WITHIN 30 DAYS**
15 **AFTER THE COMPLETION OF ITS FIRST YEAR OF OPERATIONS, A VIDEO LOTTERY**
16 **OPERATION LICENSEE IN BALTIMORE CITY SHALL:**

17 **(I) COMPILE DATA ON THE AGE, SEX, RACE, AND COUNTY**
18 **OF RESIDENCE OF ITS STATE VIDEO LOTTERY EMPLOYEES ~~OF~~ WHO WORKED IN**
19 **THE STATE DURING THE PREVIOUS YEAR; AND**

20 **(II) SUBMIT THE DATA TO THE COMMISSION.**

21 **(2) WITHIN 3 MONTHS AFTER RECEIVING THE DATA REQUIRED**
22 **UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE COMMISSION SHALL SUBMIT**
23 **A REPORT CONTAINING THE DATA TO THE GOVERNOR, THE GOVERNOR’S**
24 **OFFICE OF MINORITY AFFAIRS, AND, SUBJECT TO § 2–1246 OF THE STATE**
25 **GOVERNMENT ARTICLE, THE PRESIDENT OF THE SENATE AND THE SPEAKER**
26 **OF THE HOUSE OF DELEGATES.**

27 **(3) THE COMMISSION SHALL ADOPT REGULATIONS TO CARRY**
28 **OUT THIS SUBSECTION.**

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
30 October 1, 2013.
