## A BILL ENTITLED

1 AN ACT concerning

2 **Queen Anne's County – Winery Special Event Permits – Farmers' Markets**

3 FOR the purpose of authorizing the Comptroller to issue a winery special event permit  
4 to a Class 4 Maryland limited winery in Queen Anne's County for unlimited use  
5 for a certain amount of time each week at certain farmers' markets in Queen  
6 Anne's County; and generally relating to the issuance of a winery special event  
7 permit for use at a farmers' market in Queen Anne's County.

8 BY repealing and reenacting, with amendments,

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article 2B – Alcoholic Beverages**

21 2–101.

22 (u) (1) The Office of the Comptroller may issue a winery special event  
23 permit to a licensed Class 4 Maryland limited winery, provided that:

1                   (i)     Except as provided in paragraphs (6), (7), (8), (9), (10), (11),  
2 (12), (13), [and] (14), AND **(15)** of this subsection, no more than 12 winery special  
3 event permits are issued to the Class 4 Maryland limited winery in any given calendar  
4 year;

5                   (ii)    The permit does not exceed 3 consecutive days; and

6                   (iii)   Except as provided in paragraphs (6), (7), (8), (9), (10), (11),  
7 (12), (13), [and] (14), AND **(15)** of this subsection, no more than three winery special  
8 event permits are issued in any calendar year to any given limited winery for use in  
9 the same political subdivision.

10                   **(15) IN ADDITION TO THE WINERY SPECIAL EVENT PERMITS THAT**  
11 **MAY BE ISSUED UNDER PARAGRAPH (1)(I) AND (III) OF THIS SUBSECTION, A**  
12 **CLASS 4 MARYLAND LIMITED WINERY MAY BE ISSUED A WINERY SPECIAL**  
13 **EVENT PERMIT FOR UNLIMITED USE FOR 1 DAY EACH WEEK AT A FARMERS'**  
14 **MARKET IN QUEEN ANNE'S COUNTY THAT IS LISTED ON THE FARMERS'**  
15 **MARKET DIRECTORY OF THE MARYLAND DEPARTMENT OF AGRICULTURE.**

16                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
17 July 1, 2013.
