Courts - Unauthorized Use of Name or Likeness

3 FOR the purpose of authorizing a certain individual whose name or likeness has 4 commercial value and is used for a commercial or advertising purpose without 5 the written consent of the individual or a certain person to bring an action to 6 enjoin the unauthorized use and to recover damages for loss or injury sustained 7 by the use; authorizing certain individuals or persons to bring a certain action 8 after the death of a certain individual; prohibiting an action under this Act from 9 being filed after a certain period; prohibiting certain persons from being held liable under this Act under certain circumstances; authorizing an individual to 10 extinguish the right of all persons to license the use of the individual's name or 11 12 likeness for commercial or advertising purposes after the death of the individual 13 by testamentary instrument; providing for the construction and application of this Act; defining certain terms; and generally relating to the unauthorized use 14 of a name or likeness of an individual. 15

- 7 (3) "COMMUNICATIONS MEDIUM" INCLUDES A NEWSPAPER, A
- 8 MAGAZINE, A BOOK, A NEWSLETTER, A BILLBOARD, A TELEPHONE, A RADIO, A
- 9 TELEVISION, A RECORDING, COMPUTER SOFTWARE, A DIGITAL
- 10 COMMUNICATIONS NETWORK, A TRANSIT AD, AN AUDIOVISUAL WORK, OR A
- 11 GLOBAL COMMUNICATIONS NETWORK.
- 12 (4) "EXPRESSIVE WORK" MEANS A LITERARY, DRAMATIC,
- 13 FICTIONAL, HISTORICAL, AUDIOVISUAL, OR MUSICAL WORK REGARDLESS OF
- 14 THE COMMUNICATIONS MEDIUM BY WHICH THE WORK IS EXHIBITED,
- 15 DISPLAYED, PERFORMED, OR TRANSMITTED, OTHER THAN WHEN USED OR
- 16 EMPLOYED FOR A COMMERCIAL OR ADVERTISING PURPOSE.
- 17 (5) "Individual" includes a deceased individual who was
- 18 DOMICILED WITHIN THIS STATE AT THE TIME OF THE INDIVIDUAL'S DEATH.
- 19 (6) "NAME" OR "LIKENESS" MEANS AN ATTRIBUTE OF AN
- 20 INDIVIDUAL THAT SERVES TO IDENTIFY THAT INDIVIDUAL TO AN ORDINARY,
- 21 REASONABLE VIEWER OR LISTENER, INCLUDING THE NAME, SIGNATURE,
- 22 PHOTOGRAPH, IMAGE, LIKENESS, VOICE, OR A SUBSTANTIALLY SIMILAR

- 25 (A) AN INDIVIDUAL WHOSE NAME OR LIKENESS HAS COMMERCIAL
- 26 VALUE AND IS USED FOR A COMMERCIAL OR ADVERTISING PURPOSE WITHOUT
- 27 THE WRITTEN CONSENT OF THE INDIVIDUAL OR A PERSON DESCRIBED IN

- 6 (2) If the individual is deceased and did not expressly
- 7 EXTINGUISH IN A TESTAMENTARY INSTRUMENT THE RIGHT OF ALL PERSONS TO
- 8 LICENSE THE USE OF THE INDIVIDUAL'S NAME OR LIKENESS FOR COMMERCIAL
- 9 OR ADVERTISING PURPOSES AS DESCRIBED IN § 4-415 OF THE ESTATES AND
- 10 TRUSTS ARTICLE, AN ACTION DESCRIBED IN SUBSECTION (A) OF THIS SECTION
- 11 MAY BE BROUGHT BY:
- 12 (I) THE DECEASED INDIVIDUAL'S SURVIVING SPOUSE OR,
- 13 IF THERE IS NO SURVIVING SPOUSE, ANY OTHER HEIR OR GROUP OF HEIRS
- 14 ENTITLED TO RECEIVE, INDIVIDUALLY OR COLLECTIVELY, MORE THAN A 50%
- 15 INTEREST IN THE DECEASED INDIVIDUAL'S ESTATE; OR
- 16 (II) A PERSON AUTHORIZED IN WRITING TO LICENSE THE
- 17 USE OF THE INDIVIDUAL'S NAME OR LIKENESS FOR COMMERCIAL OR
- 18 ADVERTISING PURPOSES BY A PERSON DESCRIBED IN SUBPARAGRAPH (I) OF
- 19 THIS PARAGRAPH.

- A RIGHT TO ENJOIN UNAUTHORIZED USE AND RECOVER DAMAGES DOES
- 22 NOT EXIST MORE THAN 70 YEARS AFTER THE DEATH OF THE INDIVIDUAL WHOSE
- 23 NAME OR LIKENESS WAS USED.

- A PERSON IN THE BUSINESS OF PRODUCING, MANUFACTURING,
- 26 PUBLISHING, OR DISSEMINATING MATERIAL FOR COMMERCIAL OR
- 27 ADVERTISING PURPOSES BY A COMMUNICATIONS MEDIUM MAY NOT BE HELD
- 28 LIABLE UNDER THIS SUBTITLE UNLESS THE PERSON KNEW OR SHOULD HAVE
- 29 KNOWN OF THE UNAUTHORIZED USE OF THE NAME OR LIKENESS OF AN
- 30 **INDIVIDUAL.**

1	A TESTATOR MAY EXTINGUISH BY TESTAMENTARY INSTRUMENT THE
2	RIGHT OF ALL PERSONS FROM LICENSING THE USE OF THE TESTATOR'S NAME
3	OR LIKENESS FOR COMMERCIAL OR ADVERTISING PURPOSES AS DEFINED IN
1	TITLE 3, SUBTITLE 19 OF THE COURTS ARTICLE AFTER THE DEATH OF THE
5	TESTATOR.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any cause of action arising from the use of a name or likeness before the effective date of this Act.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2013.
