Vehicle Laws - Towing, Recovery, and Storage - Methods of Payment

- FOR the purpose of repealing certain payment alternatives that under certain 3 4 circumstances allow a person that provides certain vehicle towing, recovery, or 5 storage services to avoid having to accept payment by at least two major, 6 nationally recognized credit cards; repealing the authority of a vehicle storage facility to refuse to accept a personal check as payment under certain 7 8 circumstances; requiring a police department or other person that stores an 9 abandoned vehicle to accept payment for outstanding towing, preservation, and storage charges by cash or at least two major, nationally recognized credit 10 cards; making a certain technical correction; and generally relating to methods 11 12of payment for towing, recovery, and storage charges.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 2 Accept] ACCEPT payment for outstanding towing, recovery, 1 2 or storage charges by cash or at least two major, nationally recognized credit cards[; 3 and 4 (ii) If the storage facility accepts only cash, have an operable automatic teller machine available on the premises]. 5 6 Except as provided in subparagraph (ii) of this paragraph, if (2)7 a storage facility is unable to process a credit card payment and does not have an 8 operable automatic teller machine on the premises, the storage facility shall accept a 9 personal check as payment for outstanding towing, recovery, and storage charges. 10 (ii) A storage facility may refuse to accept a personal check as 11 payment if it is unable to process a credit card for the payment because use of the credit card has been declined by the credit card company. 12 13 A storage facility that is in possession of a towed vehicle shall make the vehicle available to the owner, the owner's agent, the insurer of record, or a 14 15 secured party, under the supervision of the storage facility, for: 16 Inspection; or (i) 17 (ii) Retrieval from the vehicle of personal property that is not attached to the vehicle. 18 19 25-203.20 **(1)** A police department may take any abandoned vehicle into custody. - 25 **(2)** A POLICE DEPARTMENT OR OTHER PERSON THAT STORES AN 26 ABANDONED VEHICLE SHALL ACCEPT PAYMENT FOR OUTSTANDING TOWING, 27 PRESERVATION, AND STORAGE CHARGES BY CASH OR AT LEAST TWO MAJOR,

- 29 A police department may not authorize the use of a tow truck under (b) 30 subsection (a) of this section unless the tow truck is registered under § 13–920 of this 31 article.
