A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2010 – Prince George’s County**
3 **– Prince George’s County Fire Department**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2010
5 to change the name of a certain grantee and certain beneficiaries; altering a
6 certain matching fund requirement; extending the deadline for a certain
7 grantee to present evidence of a matching fund; providing that a certain grant
8 may not terminate before a certain date; and generally relating to amending the
9 Maryland Consolidated Capital Bond Loan of 2010.

10 BY repealing and reenacting, with amendments,
11 Chapter 483 of the Acts of the General Assembly of 2010, as amended by
12 Chapter 442 of the Acts of the General Assembly of 2012
13 Section 1(3) Item ZA03(BE)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Chapter 483 of the Acts of 2010, as amended by Chapter 442 of the Acts of**

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That:

20 (3) ZA03 LOCAL HOUSE OF DELEGATES INITIATIVES

21 (BE) Prince George’s [County Fire Department] **VOLUNTEER**
22 **FIRE DEPARTMENT (VFD) FACILITIES.** Provide a grant
23 equal to the lesser of (i) \$250,000 or (ii) the amount of the
24 matching fund provided, to the **COUNTY EXECUTIVE AND**

17 VFD FACILITIES located in Prince George’s County.
18 Notwithstanding Section 1(5) of this Act, the matching fund
19 may consist of [real property, in kind contributions, or] funds
20 expended prior to the effective date of this Act AND THE
21 GRANTEE HAS UNTIL JUNE 1, 2015, TO PRESENT
22 EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED.
23 NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS
24 GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2015
25 (Prince George’s County)..... 250,000

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
27 June 1, 2013.
