## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2005 – Montgomery County –**  
3 **Old Blair High School Auditorium**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2005  
5 to extend the date by which the Board of Directors of the Old Blair Auditorium  
6 Project, Inc. must present evidence that a matching fund will be provided;  
7 providing that this grant may not terminate before June 1, 2014; and generally  
8 relating to amending the Maryland Consolidated Capital Bond Loan of 2005.

9 BY repealing and reenacting, with amendments,  
10 Chapter 445 of the Acts of the General Assembly of 2005, as amended by  
11 Chapter 65 of the Acts of the General Assembly of 2007, Chapter 219 of  
12 the Acts of the General Assembly of 2008, Chapter 707 of the Acts of the  
13 General Assembly of 2009, Chapter 372 of the Acts of the General  
14 Assembly of 2010, and Chapter 639 of the Acts of the General Assembly  
15 of 2012
