A BILL ENTITLED

1 AN ACT concerning

2 **Allegany County – Board of Education – Ex Officio Member – Repeal**

3 FOR the purpose of repealing certain provisions of law that require the Chairman of
4 the Board of Allegany County Commissioners or the designee of the Chairman
5 to serve as an ex officio member of the Allegany County Board of Education;
6 repealing certain provisions of law relating to the Chairman of the Board of
7 Allegany County Commissioners' compensation or reimbursement for expenses
8 for service on the Board of Education; making certain stylistic changes; and
9 generally relating to the Allegany County Board of Education.

10 BY repealing and reenacting, with amendments,
11 Article – Education
12 Section 3–201(a) and (b) and 3–203
13 Annotated Code of Maryland
14 (2008 Replacement Volume and 2012 Supplement)

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – Education**

18 3–201.

19 (a) (1) In this subtitle, “elected member” means a voting member elected
20 under subsection (d) or (e) of this section or a member appointed to an elected position
21 on the county board under subsection (e)(3) of this section.

22 (2) “Elected member” does not include a[

1 (i) County Commissioner serving as an ex officio member of the
2 county board; or

3 (ii) Nonvoting] **NONVOTING** student member selected under
4 subsection (f) of this section.

5 (b) The Allegany County Board consists of:

6 (1) Five elected members; **AND**

7 (2) [The Chairman of the Board of County Commissioners, or any
8 County Commissioner so designated by the Chairman, who is an ex officio nonvoting
9 member; and

10 (3)] One nonvoting student member, who is to advise the other
11 members of the county board on the viewpoint of students who attend Allegany
12 County public schools.

13 3–203.

14 (a) [(1) Except for the ex officio member, each] **EACH** elected county board
15 member is entitled to:

16 (1) [(i)] An annual salary set by the Allegany County Commissioners
17 in accordance with Article 24, Title 12, Subtitle 1 of the Code; and

18 (2) [(ii)] Reimbursement, after submitting vouchers, for travel and
19 other expenses.

20 (B) [(2) Except for the ex officio member, each] **EACH** elected member of
21 the county board shall be paid in 12 equal monthly installments.

22 [(b) The Chairman of the Board of County Commissioners serves on the
23 county board without additional compensation. However, after submitting vouchers,
24 the Chairman or the Chairman's designee is entitled to reimbursement for travel and
25 other expenses incurred as a result of meetings of the board.]

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
27 July 1, 2013.
