A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2010 – Prince George’s County**
3 **– Community Forklift Project**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2010
5 to alter the deadline for a certain grantee to present evidence of a certain
6 matching fund and to encumber funds for a certain grant; altering the grantee
7 of a certain grant; and generally relating to amending the Maryland
8 Consolidated Capital Bond Loan of 2010.

9 BY repealing and reenacting, with amendments,
10 Chapter 483 of the Acts of the General Assembly of 2010, as amended by
11 Chapter 639 of the Acts of the General Assembly of 2012
12 Section 1(3) Item ZA02(BB) and Item ZA03(AZ)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:
