1 AN ACT concerning

2 State Government – Mental Health and Law Enforcement Advisory Board

3 FOR the purpose of establishing the Mental Health and Law Enforcement Advisory 4 Board; providing for the composition, chair, and staffing of the Board; $\mathbf{5}$ prohibiting a member of the Board from receiving certain compensation, but 6 authorizing the reimbursement of certain expenses; requiring the Board to 7 make recommendations regarding the establishment of a certain center, report 8 its findings and recommendations, on or before a certain date, to the Governor 9 and certain committees of the General Assembly, and provide ongoing support and assistance to a certain center; and generally relating to the Mental Health 10 and Law Enforcement Advisory Board. 11

1 (E) THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE, THE 2 DEPARTMENT OF JUVENILE SERVICES, AND THE DEPARTMENT OF PUBLIC 3 SAFETY AND CORRECTIONAL SERVICES JOINTLY SHALL PROVIDE STAFF FOR 4 THE BOARD.

5 (F) A MEMBER OF THE BOARD:

6 (1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE 7 BOARD; BUT

8 (2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE 9 STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE 10 BUDGET.

11 (G) (1) THE BOARD SHALL MAKE RECOMMENDATIONS REGARDING 12 THE ESTABLISHMENT OF A MARYLAND CRIMINAL JUSTICE AND BEHAVIORAL 13 HEALTH STATE TECHNICAL ASSISTANCE CENTER THAT WILL:

17(II) ASSIST COUNTIES IN MONITORING THE EFFECT OF THE18MENTAL HEALTH INTERVENTION PROGRAMS;

19(III) DISSEMINATE AND SHARE EVIDENCE-BASED PRACTICES20AND BEST PRACTICES AMONG COUNTIES THAT HAVE RECEIVED GRANTS;

(IV) ACT AS A CLEARINGHOUSE FOR INFORMATION AND
 RESOURCES RELATED TO CRIMINAL JUSTICE, JUVENILE JUSTICE, MENTAL
 HEALTH, AND SUBSTANCE ABUSE; AND

(2) ON OR BEFORE JUNE 30, 2014, THE BOARD SHALL REPORT
