19 (1) where the registrant is a student or the registrant's child **OR** 20 **WARD, IF THE REGISTRANT IS THE GUARDIAN,** is a student or receives child care, if:

the principal of the school, or the owner or operator of the registered family child carehome, licensed child care home, or licensed child care institution, as applicable; and

3 (ii) the registrant promptly notifies an agent or employee of the 4 school, home, or institution of the registrant's presence and purpose of visit; [or]

5 (2) for the purpose of voting at a school on an election day in the State 6 if the registrant is properly registered to vote and the registrant's polling place is at 7 the school; **OR**

8 (3) FOR THE PURPOSE OF ATTENDING OR PARTICIPATING IN 9 WORSHIP OR OTHER ACTIVITY SPONSORED BY A HOUSE OF WORSHIP IF:

10(I) WITHIN THE PAST YEAR THE REGISTRANT HAS BEEN11GIVEN THE SPECIFIC WRITTEN PERMISSION OF THE SENIOR CHURCH12LEADERSHIP; AND

(II) THE REGISTRANT PROMPTLY NOTIFIES AN AGENT OR
 EMPLOYEE OF THE SCHOOL, HOME, OR INSTITUTION OF THE REGISTRANT'S
 PRESENCE AND PURPOSE OF THE VISIT.
